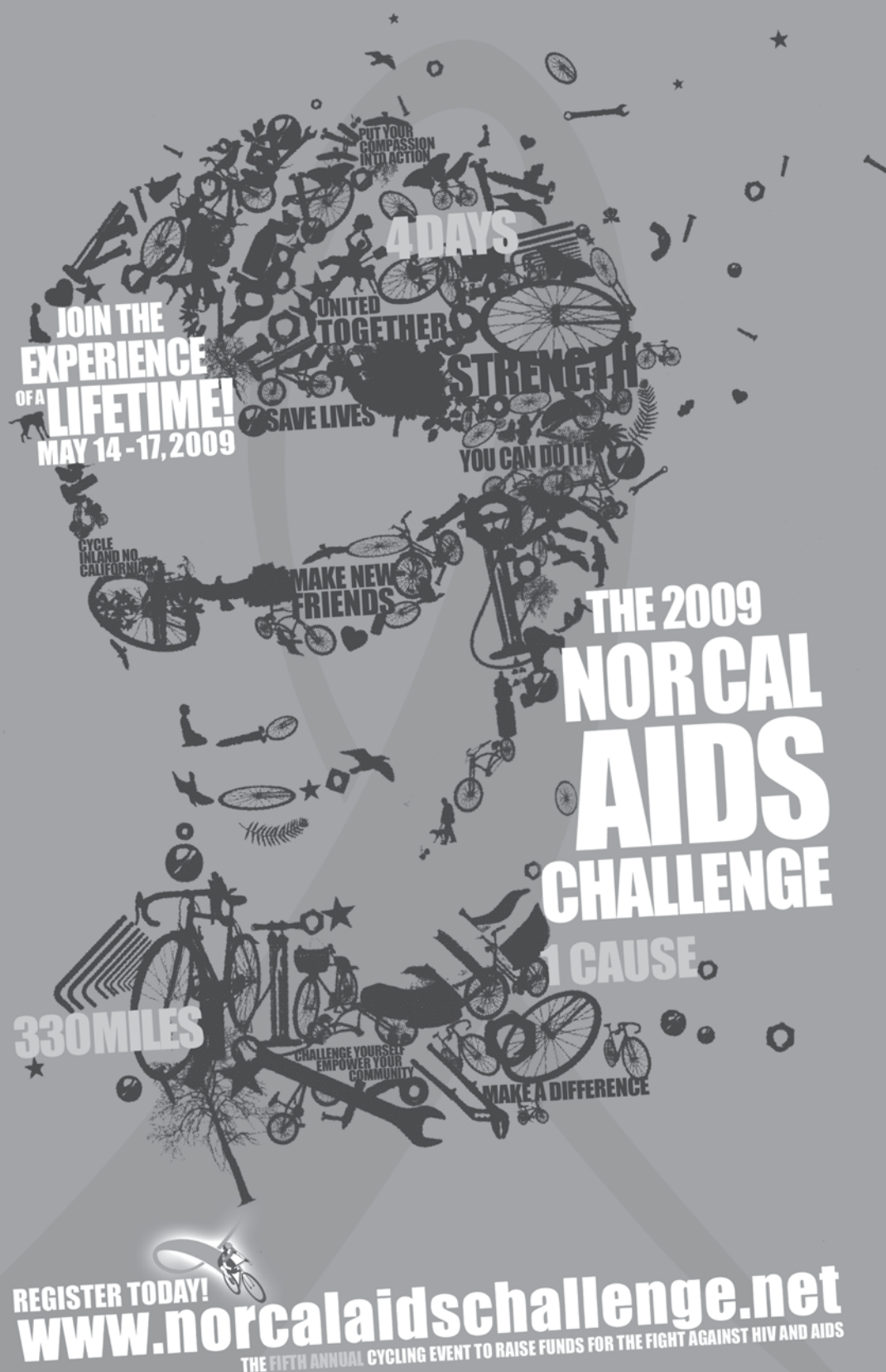

TRANSSEXUAL ALLEGES POLICE DISCRIMINATION

My name is MC Parks. I was arrested on 03/15/09 for DUI. I noticed when I left the bar I worked at, FACES, a CHP pulled out at the same time and started to follow me. As I was driving there were two cars in front of me and one that pulled in-between me and the CHP officer. When I got ready to turn to go toward the freeway he pulled me over.

When he came up to my car he asked me why I was speeding. I explained to him that I was going with the flow of traffic. He then asked me for me ID and registration. After giving it to him he then asked me to follow his finger. After about a minute he then asked me to get out of my car. As I was doing so I could

see him laughing. He asked me to come over to his car and once again follow his finger. He then stopped moving his finger and asked the other officer that was not looking at me if he noticed my eye was jumping. The other officer took a moment then stated, "yes". The officer then asked me if I have had anything to drink that night. I told him that I had a Vodka Redbull at 8:30 p.m. and finished around 9:15 p.m. He asked me if I had taken anything. I told him that I had taken two vicodin due to I get really bad migraines. I told him I took one around 11:30 p.m. and another just after 2 p.m.

He then asked me to place my hands to my side and stand on one foot and count for him. I did as he asked and when he asked me to stop he asked if I would take a Breathalyzer test. I told him "yes I would". After taking the test he asked me if anyone could have put anything in my drink. I stated to him that I was not sure do to I work at the bar and my drink sits on the counter. He then placed me under arrest for DUI. I asked him what I had blown [on the Breathalyzer] and he would not give me an answer. I asked two more times and still got no answer. I then asked him if I could call my roommate to come and get my car and he stated no that it was to be towed.

I was arrested around 2:30 a.m. They then took me to the station and the officer thanked me for being cooperative with them. When we got into the station I was taken into another room and asked again to take a Breathalyzer test. I did take it and when the result came out the officer stated that it came down substation (sic) and I was at a .2. I was then told that the money in my purse and items would be counted out in front of me and I was asked to remove my jewelry items and belt. I did remove all items and was then placed on a bench to be patted down. The items in my purse were never counted in front of me at any time.

The arresting officer asked me if I wanted to be placed in a cell by myself due to being a transsexual and I stated, "yes". As I was being patted down the officer that was doing it asked me in a very rude voice if my hair was a weave. I stated to him that it was not asked he then asked again in a rude tone. I repeated that it was not and then he stated again in a rude tone that if it was a weave that they would have to take it out. I stated again that it was not.

As I was being walked to another room a female officer in a very loud, rude voice told me that I needed to zip up my told (sic) and I stated to her that she needed to be nicer. When I was taken into the other room to have the nurse look at me the main officer told me that the female officer was not being rude. I explained to him that she was and there are ways of asking someone to do something and the way she did it was rude. After the nurse got done, I was photo and placed in my room.

After being in my cell for about an hour an officer came to my room and opened the door. He then said he wanted to ask some questions and hopefully I would not find them "rude". He asked me if I was a man and I stated "yes" I was. He then asked me if my "tits" were real and I stated, "yes". Then he asked me if I still had a [penis]. I then asked him if these were questions he should be asking when they were already told what I

was. He then closed my cell and went over to the other officers and began to tell them what he had asked me and they all began to laugh.

I was placed in my cell just a little after 3 a.m. When the officers were making rounds to check on the inmates, they would skip over mine and as they walked by my cell they would laugh. As time passed I tapped on the cell window to see when I would be released and a black officer came to my window and asked me what I wanted. I asked him when I would be released and he stated in about an hour but if I continued on I would be there longer. As he was leaving my cell I could see him say the word "faggot".

After that I was processed to leave just after 11 am. I was moved to a far cell after they did the finger-printing on me. When I was placed in that cell I could see the officers checking on inmates but they never came to my cell. When I finally got an officer to come over to me I asked if I could have a blanket due to I was cold and I was not wearing a lot. I was told that I could not have one. I could see the other inmates in another cell did have blankets so I did not understand why I was not allowed to have one.

I was then moved again to my final cell to wait for the final paperwork to be released. The officer that placed me in that cell came to my cell three times and kept asking me why I was still there. I could see people being released that had arrived at the same time I did and people that arrived after me were being released. I was finally released from jail at 5:30 p.m. — 14 1/2 hours from the time of my arrest.

The way that I was treated when I was in jail, I feel as though I was sexually discriminated against. Since my release I have now asked my doctor for anti-depressants due to I do not feel safe any longer from the officers that are here to protect me. I am scared now to go out of my house or to drive due to I feel that if I ever need help from an officer that I will not receive that help due to me being a transsexual.

I have goe though a lot in my life with the common person on the street and have learned to deal with the things that they call me or do to me — but I never in my life thought that somebody here to honor the law and protect me would treat me the same way as a person on the street. What I went through in jail makes me almost not want to continue [living openly as] a transsexual but I know if I do stop, I would let rude people win and I will not allow that to happen.

I am writing this because I feel that somebody has to take a stand so that nobody has to go through what I have gone through.

Respond to Medical Pot Raids with Legalization

Activists are outraged over President Obama's raid of Emmalyn's California Cannabis Clinic in San Francisco, but they should not be surprised.

Obama's attorney general, Eric Holder, had promised to end federal medical marijuana raids as conducted by the Clinton and Bush administrations, leaving alone dispensaries operating legally under state law. Obama broke the spirit of the promise, but not the letter. The excuse for this last raid was state law violations — supposedly, sales taxes were being evaded. Now the feds will probably prosecute under federal law.

The state government was not agitating for a crackdown. Sacramento was not complaining about sales tax evasion. San Francisco had given a permit to this dispensary.

"It is disturbing that, despite the DEA's vague claims about violations of state and federal laws," Aaron Smith from the Marijuana Policy Project noted about the Drug Enforcement Agency, "they apparently made no effort to contact the local authorities who monitor and license medical marijuana providers."

Furthermore, sales tax violations are rarely handled this way. The California chapter of the National Organization for the Reform of Marijuana Laws points out, "The normal process in such cases is for the Board of Equalization to audit the business in question, not for federal agents to enter like storm troopers and steal all of the business's

inventory."

This episode should remind liberal pot activists of the potentially despotic power involved in tax collection. The power to tax is the power to destroy. Raids like this are unusual but not unheard of in mere tax cases. Presumably, if California's marijuana industry were governed only by libertarian law — no violence, no theft, and no fraud — there would be far fewer excuses for the feds to step in.

Short of exempting medical marijuana from sales tax altogether, how can future outrages be prevented? California should go on the offensive. It should legalize marijuana, leave its regulation to the market, and, for now, treat it like any other retail good in terms of tax law.

The state could do so by treating marijuana as a legal medicine, thereby protecting users and distributors from federal sanction, assuming Obama keeps his promise to the letter. California could make medical marijuana completely legal — like aspirin or cough syrup — and allow retailers of all types to sell it without license or prescription.

Marijuana could be sold in grocery stores and pharmacies as an over-the-counter treatment. It could be made available everywhere. This measure would make it much harder for the feds to raid facilities as though they were underground, barely legal operations. It would expose the contradictions in the Drug War.

The Drug War is a total disaster. It has failed to significantly reduce drug abuse while violating personal liberty, serving as an excuse to shred the Bill of Rights, and being the major cause of gang violence, whether in our inner cities or on the border with Mexico.

If America ended drug prohibition, the Mexican border violence that has killed thousands over the past couple of years would end completely. Unfortunately, Obama is moving in the wrong direction, sending more troops to the border. Such state violence has forced the drug market underground, and every successful breakup of a dominant cartel only opens up a vacuum inevitably filled by other smaller groups violently competing over turf. The more the government cracks down, the worse it will get.

On medical marijuana, Obama was supposed to signify a shift in policy. His last DEA raid should put that myth to bed. By legalizing medical marijuana in 1996, California forced the issue over whether federal drug laws should supersede local standards. In terms of public opinion and political pressure, much has been won. It's time to keep pushing.

In *Gonzales v. Raich* (2005), the Supreme Court's five liberals all voted for federal supremacy over California's medical marijuana laws, so more court cases might not be the answer. California should instead continue to liberalize its drug laws. Doing so will, at least, complicate Obama's policy of federal raids and further undermine faith in the national government setting drug policy.

Marriage Progress In Two States

There was good news, on same sex marriage, out of two states today. In Iowa, the state Supreme Court ruled that Iowa must allow same sex couples to marry. In Vermont the state General Assembly approved a bill to allow same sex marriage in that state.

In Iowa, authorities will have to allow same sex couples to marry beginning April 24. On that date, Iowa will become the third state currently allowing same sex couples to marry. The others are Massachusetts and Connecticut.

The Decision in Iowa is remarkable in that it is the first state in the generally conservative mid-west to allow same

sex marriage. It is also remarkable in that the Supreme Court Decision in favor of same sex marriage was unanimous. Same sex marriage also became legal in both Massachusetts and Connecticut as the result of decisions by their Supreme Courts. But, in each of those cases the Courts were divided. In each of those states a bare majority of the justices ruled in favor of same sex marriage.

Supreme Court Justice Mark Cady, who wrote the unanimous decision, said, Iowa's gay marriage ban "is unconstitutional, because the county has been unable to identify a constitutionally adequate justification for excluding plaintiffs from

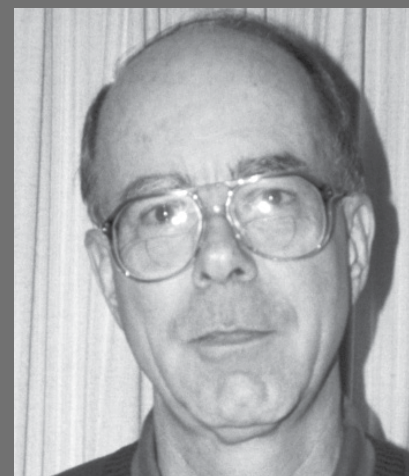
the institution of civil marriage," Cady dismissed the concept of allowing civil unions, as distinct from marriage, as an only option for gay couples. He said, "A new distinction based on sexual orientation would be equally suspect and difficult to square with the fundamental principles of equal protection embodied in our constitution."

The ruling also addressed what it called the "religious undercurrent propelling the same-sex marriage debate," and said judges must remain outside the fray. It said, "Our constitution does not permit any branch of government to resolve these types of religious debates and entrusts to courts the task of ensuring that government avoids them." And so the court's ruling explicitly stated that the decision does not affect "the freedom of a religious organization to define marriage it solemnizes as unions between a man and a woman."

So, according to the decision, the state must issue marriage licenses to same sex couples, but churches and other religious bodies do not have to solemnize them.

In Vermont, the Vermont State General Assembly yesterday approved a bill (S. 115) to allow same sex couples to marry in that state. The bill had originated in the State Senate and had been approved in that house before being sent to the General Assembly. A staff member in the bill author's office said that the bill now goes to a two house conference committee because the bill was amended slightly by the Assembly after having been approved by the Senate. She says she expects the differences to be resolved quickly and the bill should be on the Governor's desk by Monday, April 6.

The Governor is expected to veto it that day. It is probable that the Senate will vote to override the Governor's veto the next day. It approved the bill previously on a vote of 26 to 4. However, the General Assembly approved the bill on a vote of 95 to 52. One hundred votes are needed in the Assembly to override a veto. So override in that house is uncertain at best. We should know the outcome by late this coming week.

Tent City Sacramento

"Lil' Mary" Buck is grateful today. Cycles for Hope, an organization that collects donated used bicycles and repairs them to give away to the homeless, gifted her with mobility. Buck, 42, native to the greater Sacramento area has lived in the now infamous Tent City for more than a year.

In midtown Sacramento, a short walk over the embankment from 20th street, takes you to Buck's community of hundreds if not thousands of people like her, living in tents scattered along the river and surrounding fields. It is impossible to see the extent of the community from any one point, sprawling in little tent neighborhoods tucked along the rocks, trees and industrial rubble near the river.

It was not always like this for Buck. She worked as a carnival ride operator making ends meet; living close to the edge but taking pride in what she did. "Parents always complimented me. I gave their kids extra rides whenever it was slow; it was about making people happy." Buck says. "I like working with kids, I have grandchildren of my own now. I wish I could be a better grandmother." After only being able to find nine months of work one year, and less the next, Buck decided she could no longer be a burden on her children, she had too much pride for that. She moved to the streets and later to Tent City.

Life for Buck is hard, but she sees herself getting out of Tent City one day. She is trying to save enough money to fix her damaged front teeth. She believes this will help her get a job. "I've been looking and trying, but nobody wants to hire me. I will get through this somehow. I always pictured myself at this point in my life

having the little house, car, you know, the regular things."

As the residents of Tent City or being pressured to leave or face legal repercussions by the City of Sacramento Buck packed up her tent and handful of possessions. As she did, a sudden and brief downpour soaked the few blankets she uses to keep her warm from the chilly nights.

"SMUD owns this property, and they want us off. They have some place for people to go they say, but I'm going to leave room for someone who needs it more, she says thoughtfully looking around at the expanse of tents. "I'm going under the 12th Street Bridge."

There are other residents of Tent City who only a short time ago had homes, jobs. Drank coffee at Starbucks and leisurely lunches at downtown restaurants. But the recession has left them huddling together in a make-shift city, not knowing where their next meal is coming from, or whether their nightmare will ever end. One must wonder how many paychecks away any of us are from being on the streets.

As Buck spreads her blankets out to dry and examines her new bicycle, she peers down the train tracks a few yards away. "Look at that, it's amazing!" Buck said. What seemed to be an endless line of military tanks on flatbed train cars rolled by as an eerie reminder of the ongoing war, and its costs.

21st Century M-1 Abrams tanks cost roughly \$1.3 apiece — enough for an average person to live comfortably for 40 years.

Garlic serves many purposes- the banishment of vampires, holistic medicine, and breath-ruiner- but for Cecilio Ascuncion, it was a career-changer. "I was working at the Hotel Intercontinental in Manila, Philippines as Garde Manger, and I'd sliced tub after tub of garlic. It suddenly hit me that the kitchen wasn't the place for me- I'm too much of a Chatty Cathy for the kitchen," he explains. It set him on the path (though very roundabout) to Sacramento, and The Greens Hotel.

Raised in a non-traditional Filipino family with whom Cecilio is very close, he is devoted to his mother. He is also thankful that she lives close enough to drop by delicious, homemade Filipino snacks, but not too often. His stepfather, a pastor, has also been a major influence in his life. "When I asked him if it bothered him that I was gay," Cecilio says, "he said, 'You are my son first, and a gay man second.' It really meant a lot to me."

Born in the Philippines, he first came to the United States in the late '90s for culinary school at the prestigious California Culinary Academy. Cecilio returned to the Philippines where he did a few food-styling commercials and was art director for a now-defunct food magazine. He returned to the US several years later to attend college in New York, where he graduated near the top of his class with a BA in Hospitality.

Cecilio's beginnings in hospitality were quite humble- he was a phone operator for the Crown Plaza Hotel. His cheerful demeanor and ineffable work ethic landed him progressively better jobs in high end hotels across the Northeast. Eventually, he found himself on the west coast, in San Francisco.

Part of Cecilio's decision to come to Sacramento was for a relationship. The opportunity to start anew in Sacramento presented itself via The Greens Hotel, and he decided it would be a refreshing change from San Francisco. While he does occasionally miss the excitement of the big city, he really enjoys the more laid back work environment he has here in Sacramento. While the relationship didn't end up working out, he doesn't regret his decision to relocate.

Cecilio is tremendously dedicated to his work at the hotel. As General Manager, he's become the face of the hotel, and works very closely with its owner, Dan Friedlander to ensure that the hotel's philosophy- that luxury and affordability need not be mutually exclusive, and should come without pretense- comes through in the everyday operation of the hotel.

"I hate pretense, but I love beautiful

things- which is really what the hotel is all about. Our aim is to make luxury accessible to people who might not otherwise experience it, and without the pretense that is usually associated with it."

One of Cecilio's favorite things about running a business on Del Paso Boulevard is how out of place, in a good way, the hotel seems. "I'm really proud to be part of the resurgence of Del Paso Heights. You'd expect to find a place like The Greens Downtown, or Midtown, but out here, it's really unexpected in a wonderful way- it's really nice to have a place that has gay/lesbian-friendly interests in mind somewhere other than the Lavender District."

Cecilio has a new man in his life. Several weeks ago, an adorable stray puppy wandered on the hotel grounds. Cecilio adopted him, named him Stedman, and he's become somewhat of a fixture at the hotel. You can stop by The Greens Hotel any time to meet both Stedman and Cecilio at 1700 Del Paso Boulevard. They'd be more than happy to show you around.

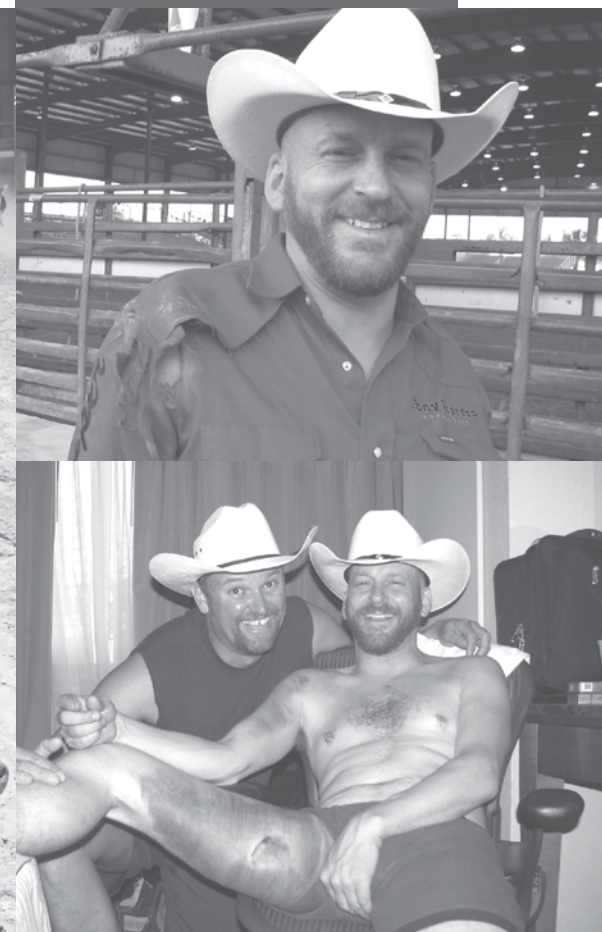
Capital Crossroads Compete In Florida

As we approach the 39th anniversary of our national Earth Day on April 22, I am heartened by the current interest in all things green. Nearly every product and service is being touted as environmentally safe, natural, eco-conscious, eco-friendly, sustainable, green or organic these days, driven in large part by demand. Recently, more than half the consumers surveyed said they were very interested in the environment and were taking action to reduce global warming and a new study shows that 82% of people are buying green in spite of the economy. State, federal and local governments are now requiring adherence to stricter standards for recycling and post consumer content in products they purchase. It's understandable why manufacturers want to be the greenest in the marketplace but one by-product of this demand is "green-washing," which refers to implying or making claims that a product or service is more ecologically friendly than it really is.

As a decorator, I am keenly aware of the rush to green and confusion over the issues represented and the range of terms used to describe ecologically responsible products and practices. I am proud of my industry for addressing environmental concerns and the current buzz of green building and furnishing products is exciting and enticing to consumers. Sorting through the marketplace to find the right products can be daunting, however.

Using low or no VOC (volatile organic compounds) paints is an easy way to start being green and is available virtually everywhere paint is sold. Some manufacturers have gone further and have a consistent track record of recycling, such as Kelly-Moore Paint Company. They have been recycling post-consumer latex paint for more than 15 years. Through their E-Coat Division. The paints are also substantially lower in price than non recycled paints although the color selection is limited.

Flooring has certainly come a long way and there are many choices for carpet with high post-consumer recycled content and recycling has become a big part of the industry. Wood, cork, bamboo and other hard surface flooring materials can also be environmentally friendly.

Solar Universe is just one of the local companies providing solar products to convert residences to sustainable power, lowering carbon emissions and saving consumers money.

Sustainable and energy efficient window treatments and fabrics are available; many are produced locally, reducing carbon footprints. Hunter-Douglas and Lafayette have earned Greenguard certification (www.greenguard.org) for some of their products. Organic cotton and even bamboo fabrics are available.

Energy Star rated appliances have become standard (although not all new appliances are Energy Star!); water



saving faucets (in addition to dish and clothes washers) are available.

Adding potted plants to your home is easy, inexpensive and will improve your immediate environment. Growing them from seed or cuttings is even more eco-friendly.

Of course reusing old items is a great way to be green; there are some wonderful finds to be had at Good Will, Salvation Army and other local thrift stores.

The internet is host to an incredible amount of information on the subject, of course and can assist consumers in their quest to become educated. Many of us in the industry are continuing our education to become experts in the field and are happy to share our knowledge with consumers and walk them through the maze of claims to select the products that will best suit their needs for function, beauty, reliability and environmental responsibility. One local resource is Green Sacramento, located in mid-town.

Industry standards are being developed and improved and as

organizations such as the Sustainable Furniture Council gain traction it will become easier for consumers to know and understand how "green" the products they're buying really are.

In summary, the best defense against green-washing is to learn as much as possible, ask a lot of questions and consult with an industry expert when in the market for environmentally friendly furnishings. Even pale green is better than no green at all! We will only improve our relationship to Mother Nature in future — the more informed and demanding we all are, the better the industry practices and products will become.

Earth day is amongst us, a time to celebrate all the blessings that this abundant planet has to offer all of its inhabitants. We breathe the precious oxygen, we reap and sow the nutrients that come from the vegetation, and it is a continuous process that allows us to live.

But what if the soil we dig in turns on us? What is the air we suck into our lungs is full of poison? This is not a set for a science fiction film, this is real. This is happening, and so very, very near to home. This is something most of us have never heard of, a dirty secret of sorts that is well known to the counties that harbor it, and the Disease Control Center that monitors its devastating effects on both humans and animals. The evil is that of concealment, knowledge is power and you are about to attain that knowledge so that you can make a much more informed decision next time you take a drive down South.

I can only tell you my story and the helplessness that coccidioidomycosis, otherwise known as "Valley Fever" can create. My partner and I have been together for over 11 years now, and she has been a Bridge Builder for over 20 years. Not any bridge builder, a top-notch foreman, a get-the-job-done, and get it done right type of person; a girl who attained the nick-name "The Girl" on the job and is very well known and respected in her field. She was sent down to Bakersfield to work for a smaller company on a side job to build a culvert. It was to last 3 weeks and she came home on the weekends in between. After 2 weeks of digging in the dirt without respirators or any kind of protection she came home for the weekend. It was the San Francisco Pride Parade weekend and we went to celebrate. To my surprise she wanted to leave early, was tired and extremely out of breath while walking uphill towards our hotel.

Stage two, we get home and she begins to feel ill. She must be coming down with the flu, so she rests up in order to get back to Bakersfield that next morning. She never gets better ... that was 10 months ago. By Sunday, she begins to have sharp pains in her chest and we need to go to the emergency room. They perform several tests and decide that she has pulled some muscles as her x-rays are clear. We return home. Over the next week she develops a high fever and sweats all through the night, soaking shirt after shirt. She cannot get out of bed. We take her to the doctor's office and the doctor says that she has pneumonia and prescribes antibiotics. Her mother informs her that her brother (who also worked with her in Bakersfield) also has pneumonia. That was strange.

She placed a call down to the owner of the company to let him know that both her & her brother had pneumonia, and to her surprise the owner also had pneumonia. This to me was unheard of, so I began investigating online. I punched in Bakersfield and pneumonia, and what the computer spit out at me was horrifying. Information on Valley Fever, its symptoms and prognosis jumped off the screen and into my lap. I ran downstairs armed with this serious information and called her doctor. Her doctor immediately ordered another x-ray and her lungs were full of fungus and it was rapidly growing. Most doctors are not familiar with this disease and it often goes undiagnosed as it takes a couple of weeks to months

to show up in the lungs and longer in the bloodstream. Her doctor called yet another doctor, one who specialized in infectious disease. She was instantly placed on 400mg of Fluconazole to inhibit the growth of the fungus, as without treatment Cocci or Valley Fever can be FATAL.

We placed calls to her boss and her brother so that they all would receive proper treatment and in the end all 12 workers had been infected with this deadly disease. They are all still off work and under doctor's surveillance. There is no cure for Valley Fever, and these workers were not adequately protected at the job, nor were they ever informed that such a danger lurked within the soil that they tore into while they labored and sucked breath after breath of the airborne fungus deep into their lungs. While it only takes one tiny spore to wreak havoc, they most likely inhaled thousands of spores. These microscopic spores cannot not be seen by the naked eye and once ingested begin to multiply into more spores, continuing on like a cancer, and spreading to virtually any part of the body. The fungus is more powerful and deadlier than anthrax. In fact, it is on the terrorist list of deadly agents and was once considered to be used as chemical weaponry, but it proved too deadly to handle, so the idea was quickly discontinued. The fungus that causes Valley Fever is regulated by the federal government in the Antiterrorism and Effective Death Penalty Act of 1996, yet people everyday go unknowingly into the depths of danger as they work in, live in, and visit the areas where it grows.

Because of the amount of spores that were inhaled by my partner and her crew, most of the workers, if not all, have been diagnosed with disseminated coccidioidomycosis. This unfortunately and diagnostically leaves a poor prognosis for my partner and her crew. The symptoms change as the disease spreads into different areas of the body, creating many systematic problems. My partner, who lost twenty pounds during the first month, now has 18 nodules and one third of those have cavitated in her lungs, she has developed arthritis in her joints, she has skin lesions, and once even woke up with a black eye. One of the most devastating effects of disseminated coccidioidomycosis is fungal meningitis, which my partner fortunately does not have at this time. However, she will most likely be on fluconazole her entire life, which puts her at risk for liver and kidney damage. As with any strong agent, this is one of the serious side effects of the medication that is necessary for her to take in order to control the growth of this deadly fungus.

When a loved one develops a life-threatening disease, you tend to become an expert of sorts on any possible solution or cure; you look at every angle for hope and reassurance. However, the disease manifests itself in different ways and doctors are still learning how to treat it, the scientists are still trying to create a vaccine to end Valley Fever, and those affected personally by coccidioidomycosis still struggle through the days, and especially the nights waiting to heal. So my friends ... roll up your windows and close your vents, especially when it is windy, while driving down I-5 towards Fresno and beyond, as it may save your life. Never dig in the dirt down south and help spread the word as most people have never heard of Valley Fever. A dusk mask will not save

you. It takes a highly technical custom-fit respirator to filter out the tiny spores. While there should be some sort of a warning posted as you drive through such a lethal area, there is not.

As for my partner, who was once so very strong and, in fact, led the tear down of the entire Carquinez bridge, and then rode atop of it afterwards as it cruised between barges down the Bay, screams out in pain each night because she cannot lift her deteriorating arms. The company where she worked for over 15 years still sends her plans for the next big job, and calls with attempts to get her back to work. But the boss who once stated that "she can outwork any man" has not seen her for almost an entire year and simply cannot fathom the devastation that has occurred within her tiny body and simply waits for the day that she can return to her former glory. The truth is this will likely never happen. Valley Fever has robbed her of her career, her health, her future, her identity, and given her reason to be distrustful. There are many others who have watched their loves ones wither away and even die, I can only share my story with you and hope that it saves someone from this disease or in some way educates others about the hidden dangers of Valley Fever. Doctors estimate that only 2 percent of those suffering from Valley Fever are properly diagnosed, although there were over 400,000 people diagnosed in 2207 nationally. In the U.S. Valley Fever is prevalent in Southern California, Arizona, Texas, and Nevada.

Symptoms of Valley Fever include:

Flu-like symptoms; Malaise/chronic exhaustion; Fever; Muscle aches; Shortness of breath/wheezing; Muscle stiffness; Coughing (can be chronic and severe); Joint pain; Coughing up blood; Joint swelling; Chest pain/pressure; Joint stiffness; Night sweats/Chills; Leg/ankle/foot swelling; Headaches; Photosensitivity; Nausea; *Vision problems/blindness Loss of appetite; **Neck stiffness; Weight loss; **Inability to focus and concentrate; Rash; **Foot drop or partial paralysis; Burning sensations at various parts of the body (foot, joints, etc.); **Severe head pain (as opposed to a normal headache)

Paragary's Bar & Grill

Paragary's Bar and Grill in Stockton. Yes, you read that right ... Stockton! Your local hometown Restaurateur Randy Paragary has ventured south with a satellite restaurant in Downtown Stockton and it is nothing short of exceptional.

Housed in the historic Hotel Stockton the restaurant is full of character and charm fully taking advantage of the historic building. Completion of the Hotel Stockton was completed in 1910 and sat at the edge of the Delta. The Hotel was designed by Edgar Brown and shows architecture elements of the Mission Revival Style. Since 1910 the

Hotel Stockton has had to reinvent itself several times over and has been used for City Hall, Government Offices, a Radio Station and many other uses the past 100 years.

Currently however, its use as a welcomed restaurant to the Stockton dining scene is by far its best!

I dine at Paragary's Bar and Grill weekly. I have held meetings in the semi-private dining room, taken my family and friends there for meals, and when my picky palate is requesting only the finest lunch, I dine alone.

The restaurant sits on the bottom floor on the west side of The Hotel Stockton overlooking the Delta. Great sunsets can be seen from the many windows that overlook the recently redeveloped area. The restaurant itself is very handsome with warm tones of brown leather seating, soft blue and brown booths, and a stunning bar that sits in the middle of the restaurant. The dining room is separated by a beautiful wood and glass wine storage area. The entire restaurant is very reminiscent of a Chop House of the 1930's, very masculine and welcoming. The high ceilings are coffered with silver inlay. Soft jazz music plays in the background as you enjoy your meal and listen to the open kitchen staff working. The kitchen offers great smells and affords those with a penchant for cooking the opportunity to sneak a peak into the real inner workings of a kitchen.

My last visit was for lunch and my dining partner was my beautiful youngest daughter Lauren. She ordered the Warm Spinach Salad that came with pancetta, egg, mushrooms, house made croutons and light sherry vinaigrette. The salad was beautifully presented and tasted spectacular. Everything very obviously fresh. I started with the Iceberg Wedge salad, which is a welcomed salad from the 1950's. The Salad was topped with homemade chunky blue cheese dressing, red onion, tomato, and radishes. Both salads were prepared perfectly and fresh.

For our lunch entrée Lauren ordered the New York Steak Sandwich with chimichurri sauce and watercress served on a homemade roll along with a side of fresh French fries. I ordered the Niman Ranch Angus Burger, which is house ground daily with locally grown red onion, tomato, lettuce and house made aioli. I had the choice of a small salad, freshly made barbeque chips or French fries. I too decided to indulge and have the piping hot fries. Both of our entries were prepared with care and arrived perfectly to our table. Everything was hot, fresh, and smelled wonderful. I was taking pictures of each item as it arrived to our table, and while they will look good in print, it doesn't do the dishes justice as part of the dining experience is the smell and taste. You can't taste a magazine. I hope that the picture entices you to try one of these dishes as each was spectacular.

The restaurant has both a great lunch and dinner menu offering many choices for many different palates. All the pasta dishes are excellent. I highly recommend the Hand cut Rosemary Pasta that is made fresh daily on site and is full of seared chicken, artichokes, pancetta, leeks, garlic and Parmesan. It melts in your mouth. The Pan Fried Petrale Sole is on both the lunch and the dinner menu. It is excellent, probably one of the best dishes on the menu. Other fish dishes include grilled

salmon with a ginger-soy glaze and recently they have offered a dinner special of Halibut served over lemon risotto. They're a lots of items on the menu for Vegetarians also.

In keeping with a true fresh menu, items change due to availability and seasonally. Nothing here is from a freezer waiting to be pulled and warmed up. It's all fresh and freshly made. All breads are made in house as well as all desserts. The pastry chef changes the menu to reflect the season and creates fresh desserts each week. The chefs working under the direction of Executive Chef Kurt Spataro are well trained themselves and take pride in what they present. If you notice throughout the review, I use the words "house made" often, that's because everything is fresh, house made, not out of a jar or freezer. Fresh....something that those of us who eat out often have forgotten about.

At my last staff meeting I held at Paragary's Bar and Grill, the head chef Buddy came out to the table and asked each of my guests if they enjoyed their meal and explained some of the dishes. It was a treat and welcomed by my staff. When he left I told them, "see....you're not at Black Angus!" It made an impact and each of them have since ventured to the restaurant on their own to try something new.

Offered at both lunch and dinner is a great wine list as well as custom made drink cocktails created by the employees to enhance your meal. Soda, tea, and filtered sparkling water are available as well.

The restaurant is offering lots of incentives to try them out and if you haven't been here, you are missing out on something memorable. Stocktonians misconception that this is an expensive restaurant is mistaken. My freshly ground steak burger was \$10.00 and came with fresh fries and homemade pickles. You can drive up the street on the Avenue and have a burger and fries for about the same, but you will miss out on the freshness, outstanding service, and beautiful surroundings. Don't let white table clothes and professional staff scare you away, this is a restaurant that makes perfect food in a great setting. You need to try it out.

Other events the restaurant is holding include a Happy Hour Tuesday through Friday from 3:00 until 6:00 with \$2.00 fries, beers, \$3.00 Panini sandwich and \$3.00 drinks including wine, lemon drops, beers, and \$4.00 Mojito's, margarita's, and beers. Another event, the "Dine Around the World" is offered the 3rd Thursday of every month. It features different world cuisine to include: French, Italian, Greek, Middle Eastern, Central American, or Asian infusion just to name a few. Call and check each month to see what the food will be for that month.

Valet parking is available for a small fee, however the redeveloped area does include plenty of parking. I personally am looking forward to see if they start to use their rooftop-dining terrace that has spectacular views of the reemerging city. If you dine there and would like to see the terrace, ask your server if they can point you in the direction. It's great view and romantic spot. It needs to be utilized!

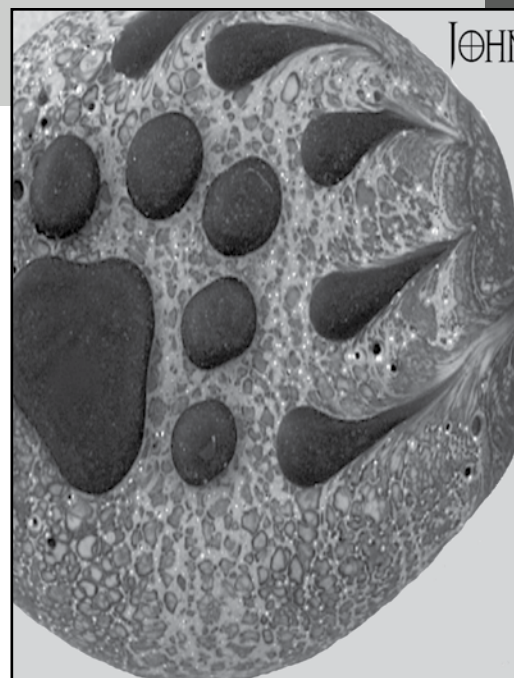

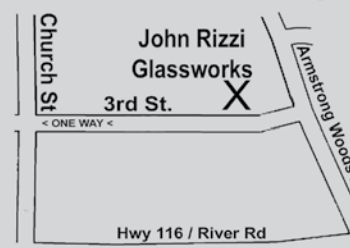

Garbeau's Closes

After launching a two-month campaign to try to save Garbeau's Dinner Theatre and twice believing they might have succeeded, owners of the 27-year-old community landmark have announced they will be closing their doors on May 31st. "We obviously misinterpreted our landlord," said Mark Ferreira, CEO and co-owner of Garbeau's.

The owners had believed that after meeting a well-publicized financial deadline on March 16th, they would be able to negotiate rent with their Washington-based landlord, Andy Lakha of Lakha Investments, Inc., headquartered in Bellevue, Washington. Instead, they were told the negotiations would be dependent on a new April 1st deadline, which was met with help from the offices of Senator Dave Cox, Senator Darrel Steinberg, and Board of Equalization Member Bill Leonard. "When we opened, we made a disproportionately large sales tax deposit," Ferreira explained, "and their offices moved with incredible speed to reassess the deposit and refund a substantial portion."

While declining to negotiate the rent, Lakha did offer to waive all past and future monies owed in exchange for a clean walk away. "We appreciate his allowing us to operate through May 31st and we hope the best for his future tenant," Ferreira said.

Garbeau's is continuing plans for their Easter brunch, comedy nights, Thursday evening karaoke, their current weekend production There's a Little Bit of Broadway in Everyone, and closing parties through May. Until then, the owners are asking everyone who has a memory at Garbeau's to come as a patron or visitor and sign a wall in their theater. "Even though it will be eventually painted over, we want Garbeau's to have a permanent presence here," said co-owner Andrea Castel.

Though reopening Garbeau's in the future is a possibility, Ferreira says discussing it is premature. "For now, we would simply like to celebrate our last production surrounded by friends." He concluded, "We did the best we could with what we had and we will be forever grateful for the community support

we've received."

Humor Times Turns 18

The Humor Times, a monthly political satire magazine launched in Sacramento in 1991 and now available worldwide, is celebrating its 18th anniversary with the April issue, out now.

Appropriately enough for a publication bent on tickling readers' funny bones, its birthday was April Fools Day, 1991. The free monthly was immediately well-received, and coming on the heels of the launch of the weekly Sacramento News & Review, it was a welcome departure from the staid political coverage of the past. Beginning with a circulation of 10,000, it quickly grew to nearly 40,000 in a few short years. The circulation was concentrated in certain areas, notably

the downtown-midtown area, and so became a favorite of downtown politicians and office workers.

The Humor Times eventually converted from a free paper to a subscription-based publication at the start of 2008. According to publisher James Israel, the economic downturn that began in 2007 "caused local businesses to begin tightening their belts, and unfortunately, that meant less advertising for us." The magazine, while "never threatening to bust into the Fortune 500," nevertheless held its own up to that point.

"We never could attract much in the way of big corporate advertising accounts," said Israel, "being that we were not the dominant weekly or daily in the area, the two types of papers that tend to attract the big ad bucks." As the recession began to take hold, and advertising dollars dwindled, it became obvious to Israel that the Humor Times could no longer afford to just give away the magazine for free.

"But there is one other publication like ours making it as a national subscription magazine, and I believe we can match their success with a little luck and financial backing," said Mr. Israel. The Funny Times is a few years older and now boasts over 75,000 subscribers. "Naturally, we have what I consider a better product, and with a national marketing push like they had, I think we could grow to the same level or bigger," Israel added, "so we will continue to seek investors."

For now, the Humor Times is on a solid financial footing, and according to Israel, is happy to be where they are, with a dedicated following of readers from all over the country. A large percentage of its subscribers are from the Sacramento area, and the company tries to remain in the local public eye by co-sponsoring and tabling at events, having booths at fairs and festivals, stocking the magazine for sale at area outlets, and occasionally placing sample back issues around town.

The 18th anniversary issue is available now in Sacramento at Newsbeat, Big Brother Comics, the Book Collector, World's Best Comics; in Davis at Bizarro World; and online at humortimes.com. Subscriptions are \$18.95/year (12 issues – a dollar less when ordered online), and a 3-issue trial subscription is available for only \$5.95. An online PDF version of the paper is available for download by subscription as well, for \$9.95 a year.

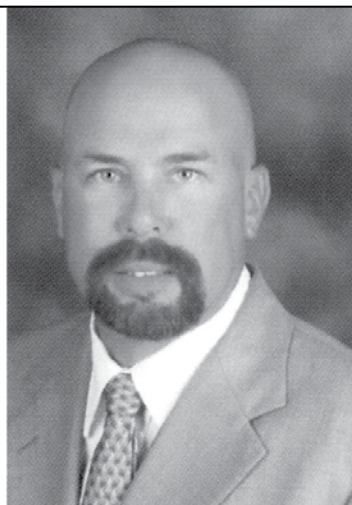

FAST & FURIOUS

Swanner: It's no surprise that I've never been a fan of the Fast & Furious franchise. It's loud and it deals with cars and gross stuff, not to mention that they are breaking like hundreds of laws during the movie. In this fourth installment and we have Vin Diesel and Paul Walker reprising the roles they originated in The Fast and the Furious. Those would be the same roles they swore they'd never do again, until their individual careers had all but died.

Judd: The cars are the only reason to watch these movies. Why did you go see this one?

I'm sure it's a lot of special effects, but it looks real and when this car wraps around a pole ... it was cool. The best part of the movie for me was Vin Diesel. Not because of his brilliant acting skills ... no, it was how hot he looked. Every scene has him in a skin tight shirt and every once in a while ... a sleeveless shirt. Those are some guns I'd allow in my house. For 42 years old he is fine. Paul Walker, on the other hand, looked older and tired. He went from "Damn, who's that?" to "Who's dad is that?" And lets face it, when Vin Diesel looks like the better actor ... well, you get my point.

At least they aren't too proud to pass up on a good thing. After this opening weekend with a box office of \$71 million you have to figure they got

something right and now they'll get paid more for the Fast & Furious: European Drive by.

Swanner: Maybe they'll hit the beach in Europe ... Vin Diesel in a Speedo!!!

Judd: There is something seriously wrong with you.

Swanner: 1 1/2 Stars

Swanner: What could be better than attending a screening of the new Seth Rogan movie? Maybe going home and watching one of his other movies would be more fun 'cause this movie kinda sucked. This is the second mall cop movie to come out this year and it's not the better of the two. He plays a security guard Ronnie Barnhardt in an ugly mall where there is a flasher in the parking lot and a night time burglar.



Judd: I think the problem with this movie is that it's rooted in a genre neither one of us particularly like. It was like a grown up, violent version of Napoleon Dynamite. It's a genre that I don't like because it's sole intent is to make a laughing stock out of characters who don't know any better. The majority of Observe is spent putting Rogan in supposedly comical situations where he's being degraded. That's not to say there aren't some funny moments. Anna Farris plays a cosmetics counter girl who loves to have a good time and character actress Celia Weston has a hysterical turn as Rogan's drunken mother.

Swanner: But that's the problem I had. His mother is a falling down drunk, he has sex with a woman who has passed out or he's hassling foreigners because they are foreign. He's an asshole and he probably has an IQ below 100. This is who I'm supposed to root for? Sure there were funny parts but the problem here is script and lead actor. His character should be the bad guy or at least realize he's a major asshole and fix it by the end. At the end...he's still an asshole.

Judd: You can't root for someone who's a borderline retarded, racist asshole? Why not? You dated one for 11 years. Anyway, I thought his character flaws were the best part of the movie - at least it gave us something

Exercise Tips & Secrets

FOLLOW AN EFFECTIVE EXERCISE ROUTINE!

I died on a table several months ago.
I know! Dramatic, right?

A little while ago I overheard a personal trainer at my gym talking about gastric bypass surgery. He was with another client, and didn't know that I had had the procedure just a few months before.

"These gastric bypass people are just taking the easy way out," he laughed to the pretty girl he was coaching, "They don't have the willpower to exercise or put down the éclair. It's sad, really, that they think they can just change their lives POOF, just like that."

I didn't say anything. Maybe I should have, but I was on hour two of my workout and was seriously debating between passing out from exhaustion or just throwing up on the rowing machine.

It did set me to thinking about my "easy way out" of obesity, though. You know, the surgery where they cut your stomach in half, rearrange your intestines, and stop you from eating solid food for a couple months. The "easy way" with a 1 in 300 mortality rate.

I spent November 4th, 2008, like it was my last day on Earth. I made it a good one. I woke up early so that I could watch the sun rise on my wall and listen to the world wake up. My cat and I watched one of my favorite movies while I scratched her ears and cleaned my room around her. She wouldn't let me do the pile of laundry in the corner, though – that was hers. I changed my sheets in case I would get to come home again and made sure that the cat had extra food in case

I didn't.

I went and I voted early in the day. I remember hoping as I put the little ink pen into the voting hole that the man I was voting for was actually the man I believed him to be. I remember hoping for a better world, and thinking that was strange since I wasn't sure I'd still be in it, or even get to see it begin.

I read the last few pages of a book I've read a hundred times at a coffee place I sneak off to, sometimes, and watched the world talk. The elections had everyone in a tense place. Everyone could feel it – the world was on the verge of change, or sinking deeper into a dark, dark place. I knew how it felt. The book was "Small Gods", by Terry Pratchett, a story by an atheist about the last man to truly believe in God.

I made love to a friend that night that was visiting from New York. He's smart, handsome, and someone that strangely only valued me for the very body I was trying to get rid of. I never told him that I was saying goodbye that night, and I never told him the reason I couldn't share one last dinner with him was because I'd had my last supper two days before.

When the elevator opened to his hotel lobby there was a woman in a business suit. I saw her tears before I saw her smile. When I realized that everyone in the lobby was laughing and smiling, I glanced at the television and realized that a new president had been elected. The new world had started when I was saying goodbye to the old one,

and people were crying with the joy of it. I remember feeling very happy that, no matter what else happened, I'd been able to see the beginning of it.

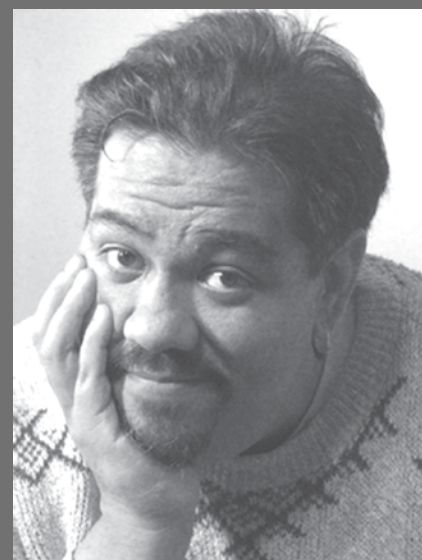
I spent my last few hours with my friends, some of the people I love best. I didn't want any of them to know I was saying goodbye. Either I would see them again and saying goodbye would have been silly, or I wouldn't see them again and saying goodbye would have been cruel. Instead, I made sure to hug each one of them and accept their well wishes for my journey the next day while I quietly wished each one of them the best of all possible lives.

The next morning, on November 5th, 2008, I said goodbye to my old life and checked into the hospital at 5:45 in the morning. A mortality rate of 1 in 300 is statistically good odds. You have better odds at winning at roulette than dying on the operating table. But sitting in a hospital at 5:45 in the morning on a Wednesday morning you tend to wonder if you're going to be seeing Thursday.

I say I died on the table during the surgery because, in a way, the person I was didn't leave the operating room. The surgery didn't change who I am, but it was the final step in my changing myself. It was the final goodbye to many of the things that defined me – the fears, the excuses, the self pity, the comfort of food, the rock solid knowledge of who I was. I knew how to function as a fat man – a fun, brassy, loud-mouthed man who knew how to use his size to every possible advantage except for self respect. I had no idea who I would be after, or if I would be especially good at being the new me. I traded the life I knew for a life I'd only imagined.

When things get hard, I think of myself on the table scared, very alone, and naked and surrounded by strangers in facemasks. Hoping that I'd made the right choice, wondering if I'd wake up again. I think of the sacrifice the old me made so that the new me could be here, and sometimes that's all it takes for me to do 10 more minutes on the treadmill. That man died so I could live. I died for me.

You can imagine what I think when I hear people suggest anyone who had the surgery took the "easy way" out. That trainer had better watch his step. The next time I won't be throwing up on the rowing machine.

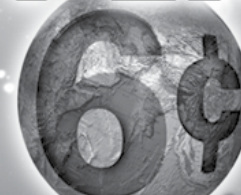

Levi Kreis: Where He Belongs

If Levi Kreis' acclaimed sophomore release, "The Gospel According To Levi", took listeners through the complicated and painful past of a young man growing up under the grip of religious fundamentalism, then it must have been cleansing for Kreis because there is no trace of hardship in the new "Where I Belong". His new CD is the most positive, uplifting offering witnessed from this piano man. We expect the "Levi hook", but this time around, they simmer with Southern soul that rings truer than any previous endeavor.

Kreis released his debut album "One of the Ones" in 2005 following an appearance on NBC Donald Trump. Combined with an exclusive CD premiere on XM Radio, the world introduction to Levi began a firestorm of conversation. Songs from his debut CD have been featured on The Apprentice, Days Of Our Lives, and The Young And The Restless spawning national television appearances and radio rotation. His sophomore CD released in 2006, "The Gospel According To Levi", garnered more television and film placement and a music video for the single "We" which held the #1 position for nine weeks on MTV's LOGO Network. With nearly 300 appearances in 2006-07, Kreis has shared the stage with Quincy Jones, Herbie Hancock, Snoop Dog, Farrel, Collective Soul, and opened for Cyndi Lauper at Wrigley Field.

Kreis's 1997 move to Los Angeles found him cast as "Roger" in a National Tour of Rent where he unexpectedly discovered his love for acting. His natural musical talents complemented his budding on-screen abilities and he was cast as one of the musical leads in the award-winning independent film "Don't let Go." After completing a few short films, Levi was invited to work with Bill Paxton and Matthew McConaughey in Paxton debut "Frailty" where Kreis played the emotional role of Adam Meiks.

In fall of 2007, Kreis took a break from touring to become the original cast member in a new hit musical called "Million Dollar Quartet", where he received astounding reviews for his portrayal of Jerry Lee Lewis, and went on to launch the official national debut at the Goodman Theatre in Chicago. 2008 provided a record-breaking run, and Kreis received enthusiastic praise from The New York Times, The Chicago Tribune, The Seattle Times, among others.

"Where I Belong" proves that Kreis has come into his own with a sound nostalgic for his gospel roots and southern soul, and promises to be the most defined chapter in this young prolific singer/songwriters promising career.

"Where I Belong" will be available May 5, but Sacramento fans will get a sneak peek and a chance to get an advanced copy Saturday, May 2 at the Levi Kreis

CD Release Party and wine tasting, 6pm at the Scoot Shop 1619A E St. in Sacramento. The event is sponsored by MGW Newsmagazine (momguesswhat.com), Valley Rainbow Pages (VRP.info) and GaySacramento.org, The Scoot Shop and Sarus Restaurant.

We caught up to Levi and managed to sneak in a few questions before his nightly performance in "Million Dollar Quartet".

Being an openly gay musician in 2009, do you still find yourself pigeon-holed into being labeled a "gay artist" and if so, does that bother you? I certainly wouldn't mind that label, and have worn it proudly in the past, but it seems to be fading a bit. I'm seeing a shift towards being called an "inspirational" artist. I like that. My goal has always been, even from the time I was a traveling kid evangelist at 12 years old, to make music that spoke for everyone and whose purpose was to heal. Either label is great, but I hope that at the end of my career I'm known for making music that heals.

You've been compared to Jerry Lee Lewis and Harry Connick, Jr. among others. Would you agree with that? You just named two of my favorite artists whose scope of influence I doubt I even recognize. Playing the role of Jerry Lee Lewis for the last year in the new rock and rock musical "Million Dollar Quartet" has impacted my own endeavors in ways I would not have expected. Beginning the writing process for my new album "Where I Belong", I found myself so easily drawn back to my roots. Southern soul, gospel, and piano players like Jerry Lee were there for me to cut my teeth on from the start. I like to think that there are traces of that on this new album. I'm very excited about this new release by the way, and feel like I have finally defined myself stylistically more than ever before.

How would you define your "style". I'm getting the terms "Americana Pop", and "Southern Soul". I'm well aware that while my history in gospel music is rich, my sensibilities as a songwriter are that of a pop song formula. I was telling my husband last night that I do believe that somewhere between my album "The Gospel According To Levi" and this new album I made the shift from songwriter to artist. I say that because after 3 years on the road, I've learned what my specific style of piano playing sounds like, what my specific vocal interpretation is, and how to surround myself and my piano with simple, supportive sounds that don't distract from the core of who I am. It was my personal revelation as an artist producing this album. It really taught me a lot about where my stylistic strengths are and how to capitalize on them from an aural standpoint. For the first time I can say that this album is undeniably who I really am at this point in time.

In your own thoughts: Who is Levi? Levi is a mess of contradictions. (laughs) Levi is a double Scorpio who is stubborn, relentless, and maybe the most ambitious man you'll ever meet. I will NOT take no for an answer. At the same time, I think Levi has only wanted to know one thing, how to see common truths running throughout all of our

diverse life experiences. I also think Levi is someone who should not talk about himself in the third person. (laughs) I am a very sexual being. I am fiercely loyal. I am slow to trust, but will pour everything into you once I've opened my heart to you. Most of all, my hope is to master the following. In life, there is always negative or positive to see. Both are always available to us in abundance. I hope I continue to become the person that can always see every situation as something to celebrate.

Tell us about the show you're in? How long is it running? Lord. Too long. (laughs) No, I love this musical and it has afforded me so many wonderful opportunities to broaden my audience. I was there from the beginning, workshopping the piece and helping to create what the role of Jerry Lee Lewis was to become. It feels like a baby of mine. Chicago was the official national launch, and while I can't confirm nor deny, there is very serious talk about London being our next destination. If readers want to get an exciting, colorful idea about what the experience of "Million Dollar Quartet" is all about, www.milliondollarquartetlive.com is a really great site.

What drew you to this production? I love this question. My favorite thing about friends of mine that see me in this production is the first thing that comes out of their mouth after the show. "Levi, I had NO idea you could play the piano like that!" I love having an outlet to tear the keyboard up. I think that is one reason why my first album "One of The Ones", while still the most popular album of mine providing me with consistent sales worldwide, bored me. It didn't let me go crazy. It was beautiful, heartfelt, and from the thousands of emails I've received spoke well of the listeners life experiences, but sometimes you just wanna frackin' rock out. (Yes, I did say Frackin', and I will miss "Battlestar Galactica" very much.) Ya know, this musical is an endearing, uninvolved book full of intriguing information about the interrelationships between Elvis, Jerry Lee, Cash, and Carl Perkins, but at the end of the day, it's simple: it's a rockin' good time. And that, my friends, is a nice escape for someone who can sometimes be rife with import. (laughs)

Are you anxious to get on the road to promote the new CD? I wish I was going to tour more exhaustively with this new release, but I will continue doing both "Million Dollar Quartet" through August while peppering some Pride appearances here and there. My team and I are forced to focus more on media exposure than live this time around since I'm committed to the show in Chicago, and to be honest with you, it could be another 2 years before I brave another 300 city tour. In the meantime, 8 shows a week plus 30 hours a week on my own music is enough for anyone to keep up with. I am certainly not complaining. I'm sure the ridiculous pace keeps me out of trouble. No, seriously, I feel so blessed during a time that is undeniably hard for all of us.

What are you up to after the show finishes? I would like to say that I will take one week vacation and hit the road for a

year, but I bet I'm going to have to recoup for a little while. However, this is great as it is giving me time to gel with a new band that I absolutely love. The more prides we do, the more we grab a rehearsal together, the more of a musical family we become. By the time I'm ready to tour again, I have no doubt we will be a well oiled machine ready to present a show that represents the best moments of all my album releases, and in a fresh, unique way. I can't wait for fans to get to know each one of them by name, and anticipate seeing them at my live shows. By the way, if you want to get the first look at them, go to my website and check out the performance video clip.

What's the scoop on the Southern Baptist Sissies Movie (if there is one)? As you may know, Del Shores has been very busy with Sordid Lives and is gearing up for a second season. "Southern Baptist Sissies" the movie is still on the table, but finding the time to do is has been the issue. This is why Del and I agreed to finally make the theme song we wrote, "Stained Glass Window" available on my new CD. So many people have asked for that song, and we are really excited to finally have it recorded. I think it really enhances the experience of the CD.

Tell us about this CD? I can't really answer this question without stepping back to "The Gospel According To Levi". "The Gospel..." was such a load off my chest; confronting my history in the ex-gay ministry, rejection from the church, etc. And while I intended to promote religious diversity through the lyrics of this body of work, there was still a confrontational nature to the album. Since then I've had the chance to meticulously comb through my past and exercise forgiveness to a degree I hadn't before. I feel freer than ever because of that. I also feel so unapologetically me that the past does not matter anymore. This is why I wanted to create a body of work that carried my own personal sense of freedom, forgiveness, and exuberance. Surrendering what we don't understand, and seeing the positive angle to life.

Is there one song that stands out above the rest on this CD? If so, Why? Absolutely. The first song, "Gonna Be Alright". I still listen to this song to remind myself of the darkest times in my life and how they seem to pan out somehow. Resolve may not come how we want it. It may not be in the time frame we want it, but things always unfold, I believe, in a way that is for our highest and best good. And I believe that is the nature of God, to give us only what is for our highest and best good. Being able to see that sometimes is a difficult task, but I'm finding the older I get, it's always there to behold.

What separates this CD from your previous works? Forgiveness, Freedom, and unshakable faith. I believe that each of us are a unique expression of God, and the world needs our unique contribution if they are to see the full picture of God. So let your God-light shine! And my sincerest of thanks to MGW and it's readers for always being so lovingly supportive of my endeavors. Peace and Blessings!

Melody Gardot

My One and Only Thrill

RDOT MY ONE AND ONLY THRILL



With her debut album *Worrisome Heart*, Melody Gardot displayed her instinctive gift for transforming the traditions of jazz and blues with "her personal kiss of life." But even her most ardent admirers will be amazed at the giant creative leap forward she has taken with the follow-up, *My One And Only Thrill*. Mixing Latin rhythms, finger-snapping blues and deep, smoldering torch songs, it's an album that seems to have been shaped from several lifetimes of love, loss and longing. Though she's still only in her early twenties, the rapturous reception accorded to *Worrisome Heart* by fans and critics meant that she suddenly found her life moving at triple speed, as Melody and her band bounced between gigs, hotels and airports as demand blossomed across several continents.

"We were touring for nine months, though sometimes I'd have a week off if I was lucky," she explains, in between bites of sushi. "But in reality, I never really had time 'off' because I was making the new record in between touring. That process was daunting, but beautiful too, because it gave me the opportunity to work and think, and work and think again, so I could reflect back rather than having to make constant snap decisions. It was an interesting way to approach making a record."

Despite her exacting schedule, she made sure that her plans for *My One And Only Thrill* had been painstakingly laid.

"We walked into the studio with all the songs written, which was important because you need to have a good idea about how the record's going to be. You need to have

an idea, work it up with the musicians and get the rhythm tracks right. Then you can decide which songs need strings and which ones can live without them. It's a process of stripping down what you're doing to make room for something else -- essentially dividing it in half to make room for the orchestra."

This meant that members of her band -- take a bow Ken Pendergast (bass), Patrick Hughes (trumpet) and Bryan Rogers (sax) -- often had to play with even more restraint than usual, though thanks to the rapport they've built up during months of performing together, she wouldn't want to go into the studio without them.

"It was as if someone was saying to them 'you could play all this stuff, but I want you to do absolutely nothing!'" she says, laughing. "Yet it was perfect because these are all my guys, and that makes the record special. I think what makes a record great is to have people around you who are instinctively in your head-space and know what you need for those tunes. These guys have played with me long enough to know that without even thinking."

Under the helmsmanship of producer Larry Klein (fresh from his Grammy-winning work with Herbie Hancock on *River: The Joni Letters* and a collaborator with such artists as Don Henley, Peter Gabriel and Steely Dan's Walter Becker), the subtle empathy that the musicians bring to their live performances is recreated on the album. Another of the disc's secret weapons is the addition of Vince Mendoza's orchestral arrangements. As well as being a solo artist and composer, the Connecticut-born Mendoza has excelled himself in collaborations with such musical thoroughbreds as Al Di Meola, Joni Mitchell, Kyle Eastwood and Joe Zawinul, and he even wrote arrangements for Robbie Williams' album *Swing When You're Winning*. On Melody's album, his arrangements run the gamut from sleek, skipping Brazilian rhythms to slow, brooding dramas. One obvious highlight is "Our Love Is Easy," a steamy epic of forbidden love in which Melody's sensual vocal rides over Mendoza's painfully intense string arrangement. Echoes of Peggy Lee or Frank Sinatra in his "Only The Lonely" period are probably no accident.

"We were recording at Capitol and Vince was saying 'if you don't start writing happier tunes you're never going to have a career,'" chortles Melody. "He was joking! In a way though, it was ironic because the lyrical sentiment of "Our Love Is Easy" sounds like everything is wondrous, yet you hear the arrangement and it echoes the sentimentality of a funeral procession as the song begins. It has that for very specific reasons, because the song is about a great love and a great love lost. There's a line 'they say the poison vine breeds a finer wine', and that's to say the things that are not necessarily offered to you sometimes offer greater promise. Therein lies the irony, that the love you're talking about is beautiful, but it's laid within the knowledge that it's impossible."

The Mendoza magic has also been liberally sprinkled over the album's title track. It's a haunting ballad which seems to hang in space, held aloft by Melody's delicate piano playing and a shimmering mirage of strings. In mid-song, the orchestra veers off on a dramatic detour, spiralling upwards in a vertiginous swirl of sound reminiscent

of one of Bernard Herrmann's Hitchcock soundtracks. Also awash in rich, moody strings is the heartfelt reverie of "Deep Within The Corners Of My Mind," while the elegant bluesiness of "Lover Undercover" (a song which she has already been testing on live audiences) has been constructed over long, legato string phrases.

But there are plenty of changes of mood too. A recurring theme of the disc is Melody's infatuation with the music of South America, especially Brazil.

"I love Brazilian music, it's one of my favorite genres," she enthuses. "...Stan Getz bossa nova years, Getz/Gilberto, Jobim, Caetano Veloso... some amazing music has come from there. I think there is a sentimentality that's very specific to the Brazilian culture itself. The voices are soft and hushed, and the lyricism is dripping with metaphors and poetics."

Melody's Latin leanings are given an outing in "If The Stars Were Mine." Constructed from percussion and acoustic guitar, it's a simple but easy-to-hum tune with lyrics painted in bright tropical colors.

"Yeah, it's got that Brazilian feel. Actually that's a song I wrote as sort of a sweet, tender song for a child. The last verse always kills me, I want to go 'awwwww!' in the middle -- 'if the world was mine I'd paint it gold and green, I'd make the oceans orange for a brilliant color scheme, I'd color all the mountains make the sky forever blue, so the world would be a painting and I'd live inside with you'. It's incredibly sweet!"

Echoes of childhood recur in her version of "Over The Rainbow," a song which has been recorded by many artists but never in Gardot's singular Latin-flavored style. She attributes her rediscovery of the piece to having spent a lot of time with her grandmother, who used to look after her while her single mother went out to work.

"She was a sweetheart, a really good woman, and apparently one of the only people in my family that I look like. Anyway, when I was little my grandmother made me watch *The Wizard Of Oz* countless times. One day years later I sat down to write and I came across these chords, and I realised it wasn't a song I was going to write but a song that had already been written: "Over The Rainbow."

In the mysterious way that songwriters have, Melody merged her memories of the song with her passion for Brazilian music, and the results are as refreshing as they're unexpected. Mendoza's sunny, supple arrangement perfectly complements her deliciously relaxed vocal, blowing the cobwebs off the much-loved tune to create a 21st century classic. "If you're going to do a cover version you have to do something different with it," Melody muses, "otherwise it's like 'why bother?'"

A year ago, much of the discussion about Melody Gardot centred on the way she'd recovered from a terrible road accident and had used music as a therapeutic lifeline. But with *My One And Only Thrill*, the topics of conversation will be her musicianship, her songwriting and her astonishing artistic growth. Ladies and gents, a star is born.

The Highest Call: The Stage Is Set

So here's this guy riding on a donkey into the city on Main Street. Hundreds of people have lined the streets to greet him, to honor him. They are screaming his name, squeezing past bodies just to get a glimpse, or maybe if they're lucky a touch. His body guards are trying to hold back the crowds. At that moment, he realizes he has rock star status. He has finally arrived. Ironically this is not the beginning of fame and fortune but the opening segue to his death. Sound familiar? This is a 2009 description of Jesus' entry into Jerusalem just before Passover and his death. Many religious denominations call this day, Palm Sunday.

As I prepared my sermon for Palm Sunday, I was struck by the magnitude of that moment, and how any one of us would have been enamored by such adoration and fame. I imagine Jesus' mental state as he approached the city, recalling the lives that were changed as a result of his acts of faith and miraculous healings. I can see Jesus scanning the onlookers for familiar faces. Randomly making eye contact with his "homeboys", the disciples, reminiscing on the many hours spent together, sharing meals, stories, and lessons learned. Lulled by the warmth of the moment, tempted, he says ... "Hey God look at the people they seem to have gotten the message. Maybe we can forgo this death and resurrection phase of the agreement. Maybe it was enough for the people to see the miracles and hear the testimonies. God made into flesh — now they believe in you. This is an awesome experience."

Then Jesus is reminded of the agreement between him and God. Jesus agreed to come to earth to live as a human for the purpose of modeling God's love. Jesus came to help us see

beyond the legalism of religion embracing the spirit of God's plan for humankind to live an abundant life. He chose to live as a man, grounded, limited, and finite. His mission was to model a type of faith that would help us supersede our earthly limitation and reach for the impossible. Jesus taught us metaphysical principles that allow human's to control their own outcomes. In one lesson he taught that humans have the ability to change the circumstances around them just by believing and articulating the desired outcome. Jesus modeled the pairing of sacrifice with the concept of gain. But now as a human, temptations arise; he's tempted to avoid the pain, to remain in his comfort zone, to cruise through life enjoying the fame he's acquired, the love of the people, and the devotion of his disciples.

But the stage has been set. The script for this portion of his life has been written. It is time to complete the mission — to follow through with the call. No matter what he does — he can't change the direction. He is now on the path to his death. Beyond the accolades of the people during his procession into Jerusalem, when he looks back on the events of the past week he can see his approval rating dropping; He can hear the murmuring of those in power who would decide his fate; He can feel the stress and strain of his physical body. Even though he loves his disciples he really can't rely on them to help him through this pain. They can't even stay up all night to pray with him in his final hours. No matter what he says they can't hear him. He tries to warn them of his demise but they don't understand. He's the only one that can fulfill the mission ... this is his calling.

He reaches for the only tools in his arsenal to keep going, affirmations! He knows he has the ability to verbalize his desired outcome and it will happen. He will become what he speaks. He will have what he says. So he recollects the promises

God shared with him about his future and his purpose. He recants them to himself out loud and to his disciples ... "I am the way the truth and the light — no one can come to the father except through me. I am the light of the world."

He has to encourage himself. He has to keep going. Despite the pain, despite the embarrassment, despite the rejection, despite the loss, he has to keep going! There's a promise of resurrection on the other side. New life, new love, new joy, new peace, if he can just make it through this moment he will experience the abundant life.

I could not resist the urge to draw an analogy between Jesus' struggle and the current struggle we are all experiencing today. Our stage has been set and the script has been written. Some of us can see the threads which held our lives together unraveling. With little or no control we watch our lives change. We live in fear, grasping at any and every opportunity to alleviate the pain.

Like Jesus, we too have a mission for our lives. We are on the path. This place, this experience is a part of that plan. The way seems difficult and bleak. The idea of facing the next stage is too much ... But like Jesus, there is a plan for us, a greater outcome. If we utilize our faith, push through this moment, gather our tools, remember the promises, and repeat them to any one who will listen, we will also see our resurrection.

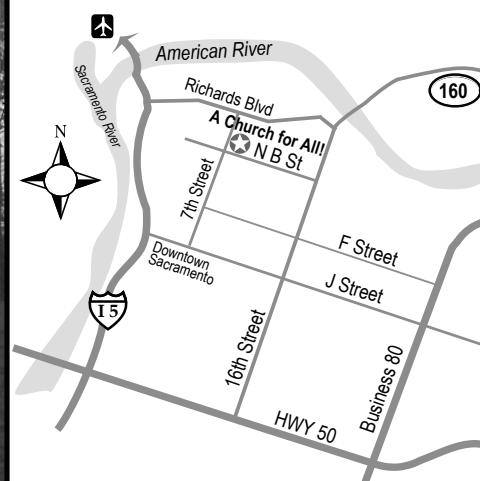
We will walk through this; and as we walk, we will find energy and endurance. Before, we felt as if we would faint under the pressure. But now as we press forward, we will find patience and peace. Eventually we will take flight and soar like eagles. Wings outstretched, floating on the wind, we will soar above our problems. We will see the big picture. Encouraged that this path will end, we will see the finish line.

The promise is ours.

I keep meeting people who say that human-induced global warming is only theory, that just as many scientists doubt it as believe it. Can you settle the score?

So-called “global warming skeptics” are indeed getting more vocal than ever, and banding together to show their solidarity against the scientific consensus that has concluded that global warming is caused by emissions from human activities.

Upwards of 800 skeptics (most of whom are not scientists) took part in the second annual International Conference on Climate Change—sponsored by the Heartland Institute, a conservative think tank—in March 2009. Keynote speaker and Massachusetts Institute of Technology meteorologist Richard Lindzen told the gathering that “there is no substantive basis for predictions of sizeable global warming due to observed increases in minor greenhouse gases such as carbon dioxide, methane and chlorofluorocarbons.”

Most skeptics attribute global warming—few if any doubt any longer that the warming itself is occurring, given the worldwide rise in surface temperature—to natural cycles, not emissions from power plants, automobiles and other human activity. “The observational evidence...suggests that any warming from the growth of greenhouse gases is likely to be minor, difficult to detect above the natural fluctuations of the climate, and therefore inconsequential,” says atmospheric physicist Fred Singer, an outspoken global warming skeptic and founder of the advocacy-oriented Science and Environmental Policy Project.

But green leaders maintain that even if some warming is consistent with millennial cycles, something is triggering the current change. According to the nonprofit Environmental Defense, some possible (natural) explanations include increased output from the sun, increased absorption of the sun’s heat due to a change in the Earth’s reflectivity, or a change in the internal climate system that transfers heat to the atmosphere.

But scientists have not been able to validate any such reasons for the current warming trend, despite exhaustive efforts. And a raft of recent peer reviewed studies—many which take advantage of new satellite data—back up the claim that it is emissions from tailpipes, smokestacks (and now factory farmed food animals, which release methane) that are causing potentially irreparable damage to the environment.

To wit, the U.S. National Academy of Sciences declared in 2005 that “greenhouse gases are accumulating in Earth’s atmosphere as a result of human activities, causing surface air temperatures and subsurface ocean temperatures to rise,” adding that “the scientific understanding of climate change is now sufficiently clear to justify nations taking prompt action.” Other leading U.S. scientific bodies, including the American Meteorological Society, the American Association for the Advancement of Science and the American Geophysical

Union have issued concurring statements—placing the blame squarely on humans’ shoulders.

Also, the Intergovernmental Panel on Climate Change (IPCC), a group of 600 leading climate scientists from 40 nations, says it is “very likely” (more than a 90 percent chance) that humans are causing a global temperature change that will reach between 3.2 and 7.2 degrees Fahrenheit by the end of this century.

Are elephant populations stable these days?

Far from it. The double whammy of poaching (illegal hunting) and habitat loss has led to a dramatic decline in populations of both African and Asian elephants in recent decades. In 1930, there were between five and 10 million wild African elephants, plying the entire African continent in large bands. Just 60 years later, when they were added to the international list of critically endangered species, only about 600,000 were scattered across a few African countries. Today that number is likely less than 500,000.

While Asian elephants were never as numerous as their African counterparts, their population numbers have also dropped precipitously, from an estimated 200,000 a century ago to less than 40,000 today. Conservationists fear that unless demand dries up for ivory, and people stop moving into prime elephant habitat, the world’s largest land mammal could become just a memory within another hundred years.

Putting an end to habitat loss may be next to impossible as more and more people vie for fewer and fewer resources and move out further into the countryside, so conservationists working to save elephants tend to concentrate on reducing or eliminating poaching. While trophy hunting of elephants may have been big decades ago, today most elephant hunters are after the ivory in the tusks, which have been a hot commodity across Asia for years as raw material for highly prized and often ornate carvings. Despite elephants’ inclusion in Appendix I of the Convention on International Trade in Endangered Species (CITES) in 1990—meaning the sale of tusks and other elephant parts is a violation of international law—poaching is bigger business than ever, with prices for ivory rising more than 16-fold in recent years.

Some countries, such as Tanzania and Kenya, are working hard to hold up their end of the CITES agreement, hiring patrols of young men—some of them former poachers themselves—to monitor local elephant populations and enforce national and international laws against killing these and other endangered species. Conservation groups like the African Wildlife Foundation



(AWF) and the Wildlife Conservation Society (WCS) are working hand-in-hand with local officials to improve elephant habitat and keep poachers at bay. These organizations hope that the people in these regions can learn how to bring in revenues from tourism instead of hunting.

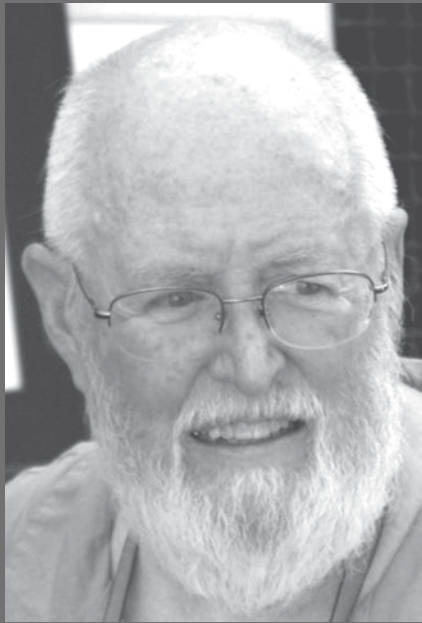
But elsewhere governments are not as committed to the ivory ban, let alone to following laws imposed by outsiders. Government officials in Zimbabwe, South Africa and Botswana, for example, argue that trade in ivory should be regulated, not prohibited. They maintain that countries that are managing their elephants well should be allowed to sell ivory in order to pay for conservation measures.

In part to test such waters, the first legal sale of ivory in a decade took place in October 2008, despite protests from conservationists. Buyers, mostly from China and Japan, eagerly snatched up some 100 tons of stockpiled elephant tusks—no elephants were killed recently or illegally for the sale—with the proceeds going to groups working to save the elephant and its habitat. But with the legal ivory sale has come an uptick in elephant poaching, leaving conservationists with that “one step forward, two steps back” feeling.

Hooray for Iowa, Vermont and Sweden!!
April brings a triple header for same sex marriage

In a brilliant unanimous decision the seven judges of the Iowa Supreme Court ruled the ban on gay marriage unconstitutional and ordered the state government to start issuing marriage licenses to same sex couples.

The Democratic controlled Vermont Legislature became the second in the nation to pass legislation legalizing same sex marriage by boldly overriding the veto of Republican Governor James Douglas thus making it the fourth state to legalize marriage between people of the same gender. Readers will recall the California Legislature twice passed legislation to legalize same sex marriage only to have it vetoed by Governor Schwarzenegger.

"Today Vermont legislators did the right thing by overriding Governor Douglas' veto and granting equal rights to all Vermonters," said Senate President Pro Tem Peter Shumlin in a statement.

And Sweden became the seventh country to make marriage between two people of the same gender legal.

Located in America's heartland surrounded by seven states, Iowa, with no residential requirements for marriage, has the potential of becoming a same sex marriage Mecca. For the most part it is less than an eight hour drive from most mid-west metropolitan areas.

The sixty-nine page opinion written by Justice Mark Cady stated the plaintiffs in the case were ordinary citizens of Iowa who expected to have all the rights granted to every other citizen of Iowa, the only difference in the plaintiffs from their fellow citizens was "They are sexually and romantically attracted to members of their own sex, and "Each maintains a hope of getting married one day, an aspiration shared by many throughout Iowa."

And it found, "Therefore, with respect to the subject and purposes of Iowa's marriage laws, we find that the plaintiffs are similarly situated compared to heterosexual persons. Plaintiffs are in

committed and loving relationships, many raising families, just like heterosexual couples. Moreover, official recognition of their status provides an institutional basis for defining their fundamental relational rights and responsibilities, just as it does for heterosexual couples. Society benefits, for example, from providing same sex couples a stable framework within which to raise their children and the power to make health care and end-of-life decisions for loved ones, just as it does when that framework is provided for opposite-sex couples."

The court also addressed the old canard about marriage being for procreation and the raising of children, "We begin with the County's argument that the goal of the same-sex marriage ban is to ensure children will be raised only in the optimal milieu. In pursuit of this objective, the statutory exclusion of gay and lesbian people is both under-inclusive and over-inclusive. The civil marriage statute is under-inclusive because it does not exclude from marriage other groups of parents — such as child abusers, sexual predators, parents neglecting to provide child support, and violent felons — that are undeniably less than optimal parents. (my emphasis) Such under-inclusion tends to demonstrate that the sexual-orientation-based classification is grounded in prejudice or "overbroad generalizations about the different talents, capacities, or preferences" of gay and lesbian people, rather than having a substantial relationship to some important objective."

The court beautifully addressed the separation of church and state issue concerning marriage noting the issue had not been formally addressed but nonetheless there was a "religious undercurrent" in the whole issue of marriage but "Our constitution does not permit any branch of government to resolve these types of religious debates and entrusts to courts the task of ensuring government avoids them ... Thus, in pursuing our task in this case, we proceed as civil judges, far removed from the theological debate of religious clerics, and focus only on the concept of civil marriage and the state licensing system that identifies a limited class of persons entitled to secular rights and benefits associated with civil marriage ... State government can have no religious views, either directly or indirectly, expressed through its legislation. This proposition is the essence of the separation of church and state." (my emphasis)

It concludes its observations of separation of church and state, "A religious denomination can still define marriage as a union between a man and a woman, and a marriage ceremony performed by a minister, priest, rabbi, or other person ordained or designated as a leader of the person's religious faith does not lose its meaning as a sacrament or other religious institution."

One can only hope the judges of the California Supreme Court read this wonderful decision and have the courage to declare Prop 8 unconstitutional.

Longtime same sex marriage activist Shelly Bailes stated on her Facebook page, "How can the California Supreme Court not vote to repeal Prop 8 when they said "The right to marry is "so integral to an individual's liberty" that it "may not be eliminated or abrogated by the Legislature or by the electorate."

Many talking heads have noted the judges seemed to be reacting very favorably to the argument all power was vested with the people and many questions were directed to Prop 8 counsel Ken Starr who went to great lengths to affirm the power of the people to discriminate.

I personally think the judges were giving Mr. Starr the rope he needed to hang himself with his ridiculous affirmations that indeed the people had the right to discriminate against any group they chose and hopefully we will see him appropriately shot down when their decision is announced.

The Iowa decision brought all the usual howls of anguish from leaders of the Radical Religious

Right. Tony Perkins of the Family Research Council lamenting about "activist judges." World Congress of Families Managing Director Larry Jacobs said he was "appalled." Americans for Truth's Peter LaBarbera, "Whenever you see homosexual activists celebrating outside a courtroom, as they were in Des Moines, Iowa this morning, you know it's a bad day for America. The liberal judges in their unchecked arrogance have now imposed counterfeit "same-sex marriage" on the heartland. If the people do not respond in righteous anger coupled with effective action, the downfall of our beloved nation is assured — because God (who invented marriage) is not mocked."

The Iowa decision was particularly heartwarming to this writer as it was just about this time 34 short years ago in my capacity as pastor of the Metropolitan Community Church in Des Moines I led the very first delegation of gay people to ever have a meeting with the governor of Iowa.

In 1975 there was no organized gblt community in Iowa and the state legislature was in the process of revising the state criminal code and we wanted to make sure the sodomy laws were dropped from the criminal codes.

So all in all Iowa has come a long way in a short time.

Now for an update on some things going on outside our borders.

The first week of April brought disturbing news of six gay men being murdered in Bagdad by either the police or religious hit squads and a café where some gays gathered to socialize was torched. It is reported all of the young men were disowned by their families and were set up by their families to be killed.

From Uganda, there are still reverberations from the anti-gay conference held in Kampala the first week of March where three American anti-gay activists, holocaust revisionist, Watchmen on the Walls co-founder and former Sacramentan Scott Lively, Exodus International board member Don Schmierer, Caleb Lee Brundidge of Richard Cohen's International Healing Foundation and the Phoenix-based Extreme Prophetic ministries, stirred up already vicious anti-gay Ugandan sentiment and now there are calls for the mass arrest of gblt people. Sentiment was further heightened by a press conference held by the Family Life Network of Uganda when a former "flamboyant" drag queen named Georgina now claims to be delivered from homosexuality and stated he had been trained and paid by foreign gay activist to recruit Ugandan schoolchildren into homosexuality. Meantime gay outings continue to appear in a national newspaper, the Red Pepper.

In Nigeria anti-gay hysteria continues as a new law is working its way through the national legislature. The Human Rights Watch explains, "The bill is entitled "Same Sex Marriage (Prohibition) Act 2006," but goes much further: it would attack all lesbian and gay individuals, families and human rights. The bill would provide for five years' imprisonment to anyone who "goes through the ceremony of marriage with a person of the same sex," "performs, witnesses, aids or abets the ceremony of same sex marriage" or "is involved in the registration of gay clubs, societies and organizations, sustenance, procession or meetings, publicity and public show of same sex amorous relationship directly or indirectly in public and in private." Any priest or cleric aiding or abetting such a union could be subject to the five-year prison term. The law would also prohibit adoption of children by lesbian or gay couples or individuals."

Nigerian Anglican Bishop of Uyo, Rt. Rev. Isaac Orama said, "Homosexuality and lesbianism are inhuman. Those who practice them are insane, satanic and are not fit to live because they are rebels to God's purpose for man."

Worldwide we are still in a struggle for freedom and it is time put the word "Freedom" back into the Sacramento Pride Festival.
