# 11 PERCENT INCREASE IN GAY HATE CRIMES IN 2008

Report shows rise in lesbian and gay hate crimes for third year in a row.

The Human Rights Campaign, the nation's largest gay, lesbian, bisexual and transgender (LGBT) civil rights organization, responded today to the Federal Bureau of Investigation report which showed the number of victims of bias-motivated crimes based on sexual orientation increased by 11 percent in 2008. The statistics show that reported hate crimes against the LGBT community have increased for the third year in a row. Hate crimes based on sexual orientation remain the third most common type of hate crimes, behind race and religion.

"These numbers are unacceptable. While it is so important that we have the new federal hate crimes law, it is critical to ensure that we continue working with the Department of Justice to ensure the safety of LGBT citizens," said Human Rights Campaign President Joe Solmonese. "We have to prosecute each hate crime to the fullest extent of the law, but we also need to get at the roots. When we don't know each other as human beings, ignorance breeds misunderstanding, which breeds hate, which too often this year led to violence. We have to keep fighting the prejudices and stereotypes

that underlie these acts."

On October 28, President Barack Obama signed the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act into law. The new law gives the Justice Department the power to investigate and prosecute biasmotivated violence by providing the Justice Department with jurisdiction over crimes of violence where a perpetrator has selected a victim because of the victim's actual or perceived race, color, religion, national origin, gender, sexual orientation, gender identity or disability. In addition, it provides the Justice Department with the ability to aid state and local jurisdictions with investigations and prosecutions of bias-motivated crimes of violence.

The new law also authorizes the Justice Department to provide grants to state and local communities to cover the extraordinary expenses associated with the investigation and prosecution of hate crimes. Moreover, it authorizes the provision of grants for local programs to combat hate crimes committed by juveniles, including programs that train local law enforcement officers in identifying, investigating, prosecuting and preventing hate crimes.

The data comes just days after the LGBT community mourned on Transgender Day of Remembrance — honoring the memories of those lost in hate crimes motivated by gender identity bias. While current data does not track crimes on based on gender or gender identity, the new hate crimes law requires the FBI to track statistics on these incidents.

The Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act honors the memory of Matthew Shepard, a Wyoming college student brutally murdered in an act of hate violence in 1998, and James Byrd, an African-American man who was dragged to death in Jasper, Texas, in 1998. # CONGRESS COMMITTEE APPROVES DOMESTIC PARTNERS LAW

Today, the House Oversight and Government Reform Committee, of the US House of Representatives, approved a bill (HR 2517) that would provide the domestic partners of federal employees the same employee benefits as are provided to the spouses of federal employees. The bill now goes to the floor of the House of Representatives, for a vote by the full House. The date for that vote has not yet been determined.

The benefits available to the domestic partners of federal employees, if HR 2517 is enacted, would include federal health

insurance and enhanced dental and vision benefits, retirement and disability benefits, family, medical, and emergency leave, group life insurance, long-term care insurance, compensation for work injuries, and benefits for disability, death, or captivity.

for disability, death, or captivity.
All federal employees (except those in the uniformed military services) and their domestic partners would b eligible for the benefits.

The committee debate on the bill was long and contentious. It lasted for over 5 hours.

The opponents of the bill first claimed that the bill violated the Defense of Marriage Act and went against the will of the American people, expressed in the many times they voted against same sex marriage. The supporters responded by saying the bill said absolutely nothing about marriage.

The opponents complained the bill would be too expensive. But then one of them proposed to amend the bill to allow a federal employee to name anyone to receive his employee benefits, not just a domestic partner. That would have greatly increased the cost of the bill. That amendment failed.

The opponents also tried to amend the bill to say that it did not amend the Defense of Marriage Act in any way. Again the bills supporters noted that the bill did not mention marriage at all, and this amendment would bring that concept into the bill for the first time. That amendment failed as well.

The opponents introduced amendment after amendment trying to either amend the bill in a way that would destroy its chances of passage, or at least to delay the final vote on the bill. But, curiously, one of the opponents seemed to complain at how long it was taking to deal with the bill. Happily the bill was finally approved and sent to the full House of Representatives.



Currently the US military prohibits LGBT people from serving openly. They can only do so if they don't tell anyone about their sexual orientation or gender identity. This prevents LGBTI people, who think serving in the military is a way of expressing their patriotism, from serving their country in this way unless they lie about or hide their sexuality. This can result in great emotional stress.

Also, in these economic hard times, many LGBTI people might want to join the military simply to have a paying job. Again, currently, this is only possible if they engage in the very stressful practice of hiding their true identity.

of hiding their true identity.

However, a report on a study done by the Palm Center, at the University of California, brings new evidence that the current policy is without any rational basis. For many years the rationale for this policy has been the claim that the presence of open LGBTI people in military units would be destructive of the unit cohesion that is essential in combat situations. It has been said this lack of cohesion would result from the discomfort of other military personnel when open LGBTI people are in their

combat units.

The Palm Center study reviewed the

attitudes of veterans of the Iraq and Iran wars. They found these war veterans said knowing that a unit member was gay or lesbian "was not uniquely related to unit cohesion". More important to unit cohesion and readiness, they said, were factors such as: the quality of leaders, equipment, and training.

Other studies have shown that the current policy is very expensive, in dollars, and it robs our military of people with critical skills. A 2005 report by the General Accounting Office, of the federal government, summarized some of those costs. The report said:

"From the passage of the homosexual conduct policy statute, in fiscal year 1994, through fiscal year 2003, the military services separated about 9,500 service members for homosexual conduct

Approximately 8 percent of the 9,488 service members separated for homosexual conduct held critical occupations, identified by DOD as those occupations worthy of selective re-

enlistment bonuses.


Also, 3 percent of separated service members had some skills in an important foreign language such as Arabic, Farsi, or Korean."

We have been hearing a lot lately about service members suffering extreme stress resulting from repeated tours of duty in Iraq and Afghanistan. Those stresses could have been reduced, at least a bit, by the larger army that would have been the result of not discharging people with critical skills. With a larger army it might not have been necessary to send people back so often.

The GAO report also estimated that it cost the military roughly \$95 million to recruit and train replacements for the service members discharged for reasons of sexual orientation between 1994 and 2003. Surely this money could have been better spent in other ways.


Hopefully, these facts will add fuel to the drive to end the US military's Don't Ask, Don't Tell Policy.

# **Blake Lewis: The 'Heartbreak' Kid**

BLAKE LEWIS IS NO STRANGER TO HEARTBREAK. BY MIKEY ROX

On the show that made him famous — "American Idol — he was voted second best to winner Jordin Sparks; his debut album, "Audio Day Dream," was released to mixed reviews and stalled at fewer than half-a-million copies sold; and at least one romantic interest in his life has let him

down not so gently.

But don't cue the melancholic music just yet. Because it seems that despite the emotional and creative rollercoaster that has defined his past couple of years, Lewis' pain is his fans' gain.

Armed with a new album, "Heartbreak on Vinyl," and a new lease on his personal and professional life, the beatboxing wunderkind returns with an organic, unapologetic record that, well, sets the

record straight.

Its message? Lewis is nobody's doormat. And that goes double for you, Clive Davis.

Mikey Rox: It's been a couple of years since you first appeared on "American Idol" – what's your take on the show now that you're an alumnus?

Blake Lewis: It's kind of surreal now. It's a great, quality show that America loves. It's fun looking back at it now. I never watched it. I'll watch some of the episodes now, and I went and saw three shows live.

That was a trip.

\*\*MR: Your debut album, "Audio Day Dream," received mixed reviews when it was released, and in an interview you once said that you "learned a lot since then."
What did you mean by that?

**BL:** By recording in a way that I did. I was constantly on tour. I worked with some amazing producers and I'm a producer myself. I learned a lot of tricks of the trade. Some are great vocal producers, some aren't. I learned a lot technically. Learned a lot about a major label. Big eyeopener. I knew I had to step up the game immediately.

MR: Your sophomore album, "Heartbreak on Vinyl," dropped in early October. How is this album different from

**BL:** It's a completely different record. My melodic sensibility is different. This is a dance-indie-pop record; I kinda describe it as that. It's very progressive. Great for driving, working out, for the club. Each track is different and unique and it's a more personal record. It's about a relationship about a woman I was in love with and also

the record industry that's eating itself up. MR: Looking back on "ADD," and with "Heartbreak" under your belt, do you feel that [your former label] Arista held a lot of the creative control?

BL: I never wanted to be with a major label. I was already signed coming out of "American Idol." I was forced into that position, but I made the best of it.

MR: How much influence did Clive

Davis have on the song selection of ADD?

BL: He passed on "How Many Words,"
a song that I was really excited about. He
tested it. It was the highest tested song on
the record. He apologized. I was right, he
was wrong. I was really upset. Business
people should stay out of the greative people should stay out of the creative process. Especially older ones who are hard of hearing.

MR: Since you're stint on "American Idol," you've been privy to some pretty cool experiences – like getting First Lady Michele Obama to beatbox at the Congressional Clubs' First Lady's Luncheon. What else has happened to you in your rise to fame, where you've been, like, 'Wow, this is awesome'?

BL: There have been many amazing

opportunities and collaborations. Michele was definitely on the top. It was pretty amazing singing in front of 1,000 women of Congress. I taught them all how to beatbox.
I was honored to be there.

MR: You're part of the growing number

of people who have participated in Adam Bouska's NO H8 photo campaign. As someone who identifies as heterosexual,

why is championing equal rights for the LGBT community important to you?

BL: Isn't that the American way? We're born in a country that's supposed to be free, yet there are all these policies and rules that allow us not to be. I support my friends who are gay and struggling with friends who are gay and struggling with issues. If I can help my friends in any way,

MR: What's on your Christmas list?
BL: I totally thought of something
this morning, and I forgot. I think I was
thinking of Christmas things to make. I'm
a photographer and I like '80s pop art and
graphic design, so I think I'll make things for my friends and family this year.

I recently went back to college to earn a degree in something other than my first two career paths. I wasn't quite sure how comfortable I would feel as a lesbian that's been out of school and in the workforce for quite some time.

As it turns out, there are lots of people my age doing the same thing, at least in night classes. As for LGBT's though, there is not so much of an obvious presence. I guess we're here and there like anywhere else, but not exactly a majority, so I initially felt a little out of place in that way.

What's new though? My second

What's new though? My second semester, I entered the classroom for the first time in my new class with no idea what the instructor was going to be like.

Of course there were way more students than there was room for, with a line of people waiting to see if they could add. I found a seat near the back of the room next to someone that looked fairly friendly, then looked up to see the instructor.

Something unexpected happened. She sort of looked like a lesbian, and my gaydar is usually pretty good. Uh oh. I sometimes find that when we (lesbians) meet each other in public places it can be a little bit awkward.

I resolved to just sit through class and act like I didn't notice. I listened as she talked to the class here and there about her children and I thought "oh boy", she's going out of her way to act like a heterosexual (I hate that), or I guess maybe she really is a heterosexual who just wears comfortable shoes. Oh, well, whatever.

As it turns out, my new instructor became my new hero with only a brief announcement on the second night of class. She had been talking about her kids here and there during the lesson, then casually turned to the class one moment and said something like "Oh yeah, didn't I tell you guys I'm gay? My partner is a woman who is also a teacher at a local elementary school. We're married, and we have two small children together. I guess all of the homophobes can leave now if

they have a problem, then the students that want to be here that there isn't room for can have a spot in the class".

She went right back to teaching the class without ever skipping a beat. Nobody left or said a word.

I had the biggest smile inside, and all I could think is "No she did not? You go girl, I'm gonna love this class!" I'll go ahead and call her "Mrs. S". It just so turns out that "Mrs. S" is also an awesome instructor with a very quick witted and sometimes borderline reckless sense of humor that the students have a great time with.

She's one of those instructors that students follow around from semester to semester so they can actually learn what they need to and get through the required classes with a passing grade that they earned. They even said she was "hot" on RateMyProfessor.com, which is something we had a good laugh with her about in the class.

On top of all of the funny stuff though, it was clear she was sincere in her desire to teach, especially for those who were struggling, which she was quite effective with.

She made struggling students want to try because they knew she wanted to help them and they could pass if they just didn't give up. She didn't go easy on anyone, she encouraged learning. We got through the semester as a cohesive group. It was a really nice learning environment.

I think "Mrs. S" set the tone from the very beginning by putting her own vulnerability and authority out there in a way that made everyone set aside their prejudices and pretentiousness and just work together.

Throughout the semester she would talk to us about her wife and their kids in a way that made the students realize our families are just like theirs. They couldn't say anything or leave anyway if they needed to pass the class, and I thought that was just awesome.

I never heard one student say anything negative about her. In fact, every time I

heard anyone say anything about what kind of teacher or person she was, it was always positive. They never mentioned homosexual.

It probably wouldn't have worked if she weren't a good teacher of her subject that had the skill to create an open environment at the same time, but she was and she did. I'm sure that there were many students in the class that changed their preconceived negative opinions toward LGBT people and families, or at least thought twice about it being OK to insult LGBT people or their families, because "Mrs. S" had the courage to stand up for all of us in a way.

She is a great teacher and role model that is a silent hero for all LGBT people and families in my mind, changing one student's opinion at a time. Initially the idea was to write this story about her and her wife, who I have never met, but I am sure is also a great teacher that deserves the same kind of recognition.

I had asked if I could take a picture of their family and do an interview about their backgrounds, etc. Her wife however is an elementary teacher at a public school. Although she wanted to be able to be "out" for this article in an effort to possibly give others the courage to stand up for all of us like "Mrs. S" has, she understandably can't. The sad reality and purpose of this story

The sad reality and purpose of this story is that there are still some people in this society that believe somehow a person that is as self sacrificing as a teacher, who they may think is the most wonderful person, all of the sudden would likely be perceived as some kind of deviant who was going to damage their children if they came out of the closet. How ignorant and ironic is that? People need more education, and those

People need more education, and those that are good educators deserver our respect and support. My hat is off to both of you ladies for your courage and dedication.

You are making a big difference for others everyday by doing what you do. I have been inspired by your example, and I wanted to share my experience with the hope that maybe someone else will be too.





# THE FANTASTIC MR. FOX

Judd: The story follows Mr. Fox (George Clooney) and his family as they try to survive attempts on their lives by the neighboring farmers. Mr. Fox has given into his wild animal instincts and has been stealing from the famers against the wishes of his wife (Meryl Streep). Meanwhile his son (Jason Schwartzman) who is "different", is competing with his visiting cousin who is handsome and athletic. As I said, Anderson is known for his retro quirkiness and just because Pixar, and more aptly Tim Burton, have refined stopmotion animation that doesn't mean there isn't there isn't a place for the unsophisticated stylings of yesteryear. It's called "reverence".

Swanner: Reverence ... really? Looks
more like cheap and/or lazy to me and I
know cheap and lazy! I don't want to make it
sound like I hated it, I didn't. I just felt it was
either too juvenile or it was too intellectual. I
know that's how Anderson works and I don't
like it. The best part of the movie (and what
won me over) was when Mr. Fox first ate
his breakfast. At that point I couldn't hate. I
think Clooney and Schwartzman were really
good voices to use but the rest were basically
forgettable. I have been whistling like Mr. Fox
all morning ... my co-workers hate me.

Judd: Yes, we know how much you
dislike thinking, so it doesn't surprise
me you find Wes Anderson an immature
intellectual — and I disagree that the other
voices were forgettable, Bill Murray gave
a good performance as the Badger, and
Willem Dafoe was excellent as the rat. What
really stuck me is how well the Anderson
trademarks worked in an animated film.
The tight close ups, the overhead shots, the
colors. All of them worked really well. They
were definite Anderson shots, but none of
them seemed forced in.

Swanner: So it was deliberate to have most of the screen over their heads empty? I figured the projectionist was drunk again. I don't want to own it but I would watch it again so I guess that shows you how much I didn't hate it. I hope Anderson has got this "animated" thing done with so he can go back to making more movies like *Life Aquatic* which he does so well.

Judd: You were trying to be funny by picking his worst movie — but *Life Aquatic* is

where Anderson got his start in stop-motion animation. So the joke's on you, Fatty. I'm curious to see how this is going to play against Up come Oscar time. *Up* is Pixar and Pixar is golden, sure. But is Hollywood finally going to get tired of handing the little golden man over to Pixar? Especially when *The Fantastic Mr. Fox* is something completely different than anything released in recent years. We'll see.



# FIRST STEP TOWARD FEDERAL SAME-SEX BENEFITS BILL ...

The "Domestic Partnership Benefits and Obligations Act of 2009," which would significantly broaden the health and other benefits available to the same-sex domestic partners of federal employees, has been approved by the House Committee on Government Reform. The bill now moves to the full House for a vote, and then thru the Senate on its journey to the President to hopefully be signed into law.

The bill (HR 2517) would extend benefits such as participation in the Federal Employees Health Benefits Program, retirement and survivor benefits, relocation reimbursements, and other benefits currently offered to spouses of federal employees. To receive these benefits, an employee would have to certify in an affidavit that his or her relationship satisfies the criteria for establishing a domestic partnership.

The Office of Personnel Management

says, "This is an essential recruitment tool as we seek the best and the brightest to tackle the many challenges America faces.

# **ELTON JOHN CONCERNED ABOUT** COMPLACENCY ...

Elton John, in a recent appearance at the eighth annual benefit for the Elton John AIDS Foundation, said he worries that young people are not taking seriously the high possibility of HIV infection. "We are finding that too many young people are not listening to what we are saying," he said. "I'm afraid people do get a little complacent about the disease by going out and having unsafe sex."

The New York City event honored dedicated supporters, including Bill Clinton and actress Sharon Stone, for their continued efforts in the fight against AIDS. It was Elton's

efforts in the fight against AIDS. It was Elton's first appearance since falling extremely ill and being hospitalized with the flu last month.

# **UNCONSTITUTIONAL TO FIRE HIV** POLICE OFFICERS ...

Poland's 1991 directive declaring that people with HIV were "entirely incapable of working" within the police force was finally struck down this month by that country's Constitutional Tribunal. The court was asked to rule on the matter after a police officer, on the force since 1998, was fired when he tested positive in 2006.

"While the presence of the AIDS virus can, in effect, be considered undesirable in the case of rescue patrols, there are a number of posts in which it is not important, such as police administration, teaching, as well as analytical and other departments," the court said in their statement. The fired officer, who was present in the courtroom, intends to return to work.

# NEW MEXICO EXPANDS MEDICINAL POT LIST ...

A New Mexico medical advisory board is recommending more chronic conditions to the list of people who can use medical marijuana. Their program provides protection from state prosecution for approved users. It has 284

approved users statewide so far.

The state already allows its use for pain and other symptoms from 14 debilitating illnesses such as cancer, glaucoma, epilepsy, multiple sclerosis, Lou Gehrig's disease, HIV-AIDS, and certain spinal cord injuries - seven of those added after a review this past February.

Now the advisory board is recommending eight additional conditions – chronic muscle inflammation accompanied by muscle weakness, severe osteoarthritis, rheumatoid arthritis, reactive arthritis, post-polio syndrome, Parkinson's disease, Alzheimer's. and severe chronic pain.



# **CANADA WARNS FLORIDA** "SNOWBIRDS" OF HIV WHILE **VACATIONING** ...

Many retired folks living in colder climates of the U.S. and Canada go south in their mobile homes for the winter – many heading for the Arizona area. But those heading to Florida are being given some strong advice this year by Canadian health officials – to be aware that they will be arriving in a community that has the highest U.S. rates of HIV/AIDS among those older than 50.
Older adults, including those dating again

after divorce or the death of a spouse, may not necessarily be aware that HIV should be a concern.

A professor of gerontology and her team at Canada's Univ of Waterloo note that HIV testing among Canadian snowbirds is "relatively low." Testing, usually prompted by insurance requirements, was reported by only one out of five respondents to a recent survey on awareness. The country's National Health Population Survey does not ask sexual health questions of those 50 or older.

The researchers are trying to get the word out, and worry that those over 50 and on vacation could be susceptible to a carefree "what-happens-in-Vegas stays-in-Vegas" sort of mentality. "We need to get a dialogue going where people are comfortable speaking about sex and sexual risk issues so that we don't see a growth of HIV infection here as they have already seen in the U.S. southern states," they said.

# OBESITY MAY ADVERSELY AFFECT MEDS...


The immune systems of obese people with HIV don't respond to anti-retroviral therapy as well as do those of people of a more normal weight, say researchers who recently presented their findings to the annual meeting of the Infectious Diseases Society of America.

"The obese were found to regain fewer CD4-positive T-cells after they start therapy than do people with normal weight," they said, indicating that these recent data may imply that obesity -- which has its own separate known ill effects -- poses an additional risk to people with HIV. This research was based on data collected from participants in the Military Natural History Study, with 1119 people who became positive between 1986 and 2008.

"The irony is that, in the past, we have been concerned that people with HIV infection were losing too much weight," said one of the participating physicians. Now, he said, "this research is showing that there needs to be more of a focus on maintaining a balanced weight without going to the other extreme.'

The researchers say it's not clear why obesity should have such an effect. Among other possibilities, they note, it might be that standard drug dosages, which are determined in clinical trials that follow people of more normal weights, may simply not be enough for obese patients. Or, there may be something about the extra weight itself that limits the effects of medications.

# AUSTRALIANS TO BE TESTED AFTER STERILIZATION ERROR...

Officials at Bundaberg Hospital in southern Queensland are recommending blood tests for 274 people recently treated at the facility's dental clinic after it was discovered that one batch of dental instruments cleaned on Nov. 6 was not subjected to the final steam sterilization process before being reused.

All those treated during that week will be tested for hepatitis A, B and C, and HIV. Health workers have so far contacted 31 of the original 33 people on whom the instruments were used. None so far has reported having a blood-borne infection.

"If there were blood-borne viruses at the onset of cleaning, the risk of transmission to a subsequent client of the clinic is considered very low for hepatitis B and extremely low for hepatitis C and HIV," said an infectious-disease physician with the Health Service.

# A HOLIDAY REFLECTION ON QUEERS, GOATS AND GOD

"Woe to the shepherds who are destroying and scattering the sheep of my pasture!" declares the Lord. Therefore this is what the Lord, the God of Israel, says to the shepherds who tend my people: "Because you have scattered my flock and driven them away and have not bestowed care on them, I will bestow punishment on you for the evil you have done," declares the Lord. Jeremiah 23:1.

Having just returned from a heavenly day spent in community with other "different" folks at the Transcending Boundaries Conference in Worcester, a day that ended with a powerful dramatic performance by Peterson Toscano, presenting his new work, "Transfigurations," about the appearance of trans personalities in Biblical stories, I can't help but reflect upon my own Christian fundamentalist roots.

I claim a personal place within the mystical ground occupied by so many who are different, who perceive the world in a different way, that is primarily intuition-based. I understand that the rational is also powerful, important, and necessary, as the grounding anchor and staircase that guides all visionaries back to the here and now. Finding the balance between these 2 ways of knowing is important and necessary.

I have been poked repeatedly by Spirit for the last 2 days, asking me, with an annoying and increasingly insistent buzzing kind of feeing, to pull my NIV Bible off the bookshelf and discover a message waiting for me there.

This morning I grudgingly obliged and opened to Jeremiah. The verse quoted above leaped off the page and I felt moved and inspired to write. I have beeen thinking alot lately about GLBT community and healing, and the recent Trans Day of Remembrance I attended in Amherst has helped clarify some ideas that have been percolating.

I was born and raised in Kansas, adopted at birth by very strict, and deeply dysfunctional Christian fundamentalist Nazarenes. My father was an angry, violent man with limited social skills and intelligence. He was raised by a violent, deeply misogynistic father who beat him throughout his childhood.

Misogyny left its mark on my adopted mother as well. She has described her childhood as happy, and I believe it was, relative to the norm for the 1940's, but something shaped her in a way that left her vulnerable to marriage with a dangerous, hateful man, and compelled her to remain as her spirit gradually warped and diminished to accommodate his domination.

My twin brother and I were pulled into their emotional maelstrom through adoption at birth. We both developed survival strategies, hiding our feelings, escaping with the help of books, tv, and daydreams, while waiting for adulthood to free us. In truth, no one is ever free from their childhood.

I'm sharing a glimpse of my roots to try to explain why I spend so much energy thinking about Christianity and formulating replies to a hateful fundamentalist mindset that holds that powerful women, gays, lesbians, bisexuals, and transgender people deserve to suffer and die. I sometimes wish I could just challenge Fred Phelps to a duel, because I know I'd win. I feel a sacred certainty in my gut that God loves me just the way I am, and that I am beautifully made, as a thinking, feeling, inquisitive, FTM intersexed individual who is unafraid to seek my own truth in a world where too many relinquish their inner compass, and replace their individuality with a life-long effort to conform and obey.

Recenty, at a friend's house, I was channel-surfing and caught a few seconds of a southern evangelist lecturing a room full of seemingly spell-bound women, telling them to guard their minds and not let in dangerous information. This female bible lecturer was specifically cautioning against studying "demonology." I chuckled, because if I had been in that room as a youngster, I would have gone straight to the library afterwards to begin researching "demonology" to try to figure out what was so scary. But the underlying message of this charismatic blonde dominatrix posing as a teacher was really: don't think too much, because it will diminish my control, and the Church's control, over you. And for those who have made a choice, somewhere along the way, to live their lives as obedient children, never embracing free will, free choice and the free thinking inherent to responsible adulthood, I'm sure her message was wholly and deeply embraced.

To me, this unhealthy emphasis on "obey and conform" is at the heart of norm-driven medicine, in all its forms, incuding psychology, which is why I personally demand a paradigm shift away from using norms to pathologize those who express radically different personal realities, including sexual orientation and gender expression.

But I also want to send a firm reply to those who teach hate in the name of Christ. I believe that if Jesus Christ were walking the planet today, he would have taught a workshop on "Unconditional Love" at the recent Transcending Boundaries Conference, held in Worcester, Ma. It is not heresy to form a personal relationship with Christ that allows for a unique, individually-tailored understanding of his message, which was 100% about holding one's personal conviction in the face of all opposition. Christ was born within an oppressed and enslaved community. He was expected, because of his bloodline, to exert a leadership role. Many around him attempted to groom him as a militant radical, someone who would command an armed revolt against the Romans.

Christ was born brilliant, with an inner awareness and a sense of destiny that allowed him to debate, even as a young child, with learned teachers. He was quickly recognized as someone different, and "special." He understood that violence could never secure a real solution to racial hatred. He taught loving patience, forgiveness, and

nonviolent communication to open minds and hearts to new ways of thinking.

He pissed everyone off, in his own community, and among the Romans, because he would not conform, would not obey, would not be shaped or led down any path he did not choose for himself. He was so sure of the power of love, that even after being tortured and impaled on a cross, one of his last conscious acts was to provide loving encouragement to a convicted thief, nailed up beside him, and publicly promise that thief a place in heaven.

I know I'm probably turning off a lot of my intellectual buddies with my fundie talk, but perhaps this isn't about you. It's about me, reconciling my view of queer community with my Christian roots.

I believe all those who call themselves Christians, including those dressed in silk and jewels representing Rome, and those in Protestant plain clothes, who teach hatred against those who do not conform, are delivering upon themselves and the heads of those who have chosen to follow in blind obedience, the same divine curse promised

by God in Jeremiah to all shepherds who

work to divide his flock.

The God who taught that goats with streaks and mottles are just as valuable as those who have pure white coats, and who sent a part of himself to Earth in the form of a son who would not conform, obey or respect any guidance that did not resound within his own heart, surely loves gays, lesbians, bisexuals, and transgender people, as well as all the other precious nonconformists within our world. We who listen to our own hearts and minds are the streaked and mottled members of the human flock. That so many of us have dedicated ourselves to nonviolent community building, patienty working to win acceptance from our larger community, without ever engaging in militant organized violence, is the most powerful testament we have to offer about the source of our deeply held convictions. All people are beautiful and beloved children of God, however we choose to name and worship the divine love that created us and holds our world together as we learn and grow. That was Christ's message, and he left it without blemish, holding strong till the end, so that this truth would never be forgotten, although so many are currently doing everything in their power

to subvert it. Fred Phelps, the Vatican, and all others who teach hatred in the name of God are part of the composite "Anti-Christ" in action.

I call upon all those who teach hatred to change their ways. I name you as heretics, as demonic, as anti-Christian, and avatars of the "Anti-Christ." You are sleepers, mindlessly obeying your deepest fears, anxieties and uncertainties. I encourage you to let go of these dark drivers and take a leap of faith into a place that is delimited by an unconditional, infinite love that is powerful enough to allow for every possible human variation. I invite you to let your minds think and imagine and explore, and to become your own judge for what is acceptable for you, and to stop projecting your fears and acting out your own self-hatred against innocent others. I invite you into responsible adulthood, as equal partners with the rest of humanity as we engage a future that is tolerant, loving and exploratory on all levels.

Blessed be, may the love of Christ fill all our hearts, and Gassho.
